# BRYAN BOWERS IN CONCERT SUNDAY, MARCH 13, 2–4PM DANBY TOWN HALL

As part of the concert series sponsored by the Danby Community Council, renowned folk musician Bryan Bowers will be giving a free performance at the Danby Town Hall. Admission is free, and all ages are welcome.

Bryan Bowers is recognized as a matchless virtuoso on the autoharp, a powerful songwriter, and an honest, spell-binding performer with a great sense of humor. From rural Virginia, where he grew up on traditional ballads and call-and-response songs learned from field hands and gandy dancers, to his current home in the Pacific Northwest, with many points in between, his has been a full life, rich in music and experience.

A Washington Times critic wrote of Bryan Bowers: "This man makes more music from an autoharp than you can imagine from a 12-string guitar and a harpsichord combined." Performing a mix of historical and new songs and tunes, he can coax a full range of emotions from his instrument: celestial, angry, wistful, hearty. No other autoharp player can rival his mastery. Yet "what radiates from the instrument under his touch is not flash, but warmth and brilliance." (Philadelphia Folk Song Society).

On the basis of his skill and innovation, Bryan Bowers won the "stringed instrument, open" category of *Frets* magazine's "First Gallery of the Greats" for five years, putting him in league with Chet Atkins, David Grisman, Itzhak Perlman, Tony Rice, and Mark O'Connor. In 1993, he was honored to join Maybelle and Sara Carter and Kilby Snow as inductees in the Autoharp Hall of Fame. But you'll find no pretension in this

down-to-earth giant (6'4"), who has a gift for connecting with his listeners.

No tickets are required and there is no charge, but a sample of Bryan Bowers' recordings will be available for purchase. This concert series is made possible by a grant from the New York State Council for the Arts Decentralization Program, administered by the Community Arts Partnership.

## AFTER THE FLUSH

Receive a discount coupon for septic system pumping. Learn about conventional and alternative systems, preventive maintenance and routine care that can prevent costly repairs and protect water quality. A free program open to everyone, sponsored by the Cayuga Lake Watershed Network and the Town of Danby, is being offered on Wednesday, March 16 from 7–9pm at the Danby Town Hall.

Thanks to funding from the Tompkins County Health Department, residents who attend the program will receive a \$20 coupon toward septic tank pumping. Pre-registration is required at the Watershed Network office (607-532-4104) or at <manager@cayugalake.org>.

The program will explain how a typical septic system works, introduce alternative methods, explain signs of system failure and provide tips.

A septic tank that is suitably located, properly installed and adequately maintained provides economical, safe wastewater disposal. Failing systems allow inadequately treated water to enter the groundwater, streams and lakes, and even nearby wells. Taking care of your system, including regular pumping, is important.

# VOLUNTEER FOR YOUR FIRE COMPANY

# OPEN SPACE PLANS AMENDED PUBLIC MEETING PLANNED

The package of open space protection measures transmitted to the Town Board by the Comprehensive Plan Implementation Task Force is being modified in response to comment. The most notable change is in how the medium density residential zone would be affected. The task force recommendation was that medium density and low density zones be combined on an interim basis into a single zone in which the new conservation subdivision procedures would apply. The second phase of the task force's work is to include creating new hamlet development zones defining areas in and near the existing hamlets of Danby and West Danby where new development would be encouraged. The town's attorney expressed misgivings about having so much of the town in one zone, even on an interim basis, with so little area available for higher density residential development. The Town Board, Planning Board, and other members of the Task Force took up the issue and settled upon a revised interim plan to put forward as part of the proposed changes to the Subdivision Ordinance and Zoning Ordinance. The map (opposite page) shows how the medium density zone would be affected. The dotted and striped areas include all of the area currently zoned medium density residential. The dotted areas would become part of the low density residential zone. The striped areas would remain medium density for the interim. The current high density residential zones are shaded.

In the Danby Hamlet, the west dividing line corresponds to the boundary of the agricultural district (lands in the ag district to the left of the line would be in low density). The south line moves the zone boundary to the rear lot lines of the properties bordering Lieb Road, where the Zen Center is located. In West Danby, the medium density zone would be pulled back to the water district boundary, with land now medium density outside the water district becoming part of the low density zone. In addition, land currently part of the Biodiversity Preserve, south of the hamlet, would also be excluded from medium density. More detailed maps showing all zones, including commercial and planned

development zones and individual lot lines are available for viewing in the Town's Code Enforcement Office for anyone wanting to scrutinize this proposal more closely. If adopted, these changes in zone boundaries will probably remain in place for a couple of years while we conduct our strategic planning for the hamlets.


At the time of transmittal of the proposals from the task force to the town board, language for the changes was not yet fully developed due to questions that needed the advice of the town attorney to resolve. Those questions are now being addressed and the language finalized accordingly. The results will be posted on the town's web site (http://www.town.danby.ny.us/) and will be the subject of another public information meeting at 7 pm on March 14. This meeting is in addition to the formal public hearing (likely in April), and will include an overview of the proposed changes which I outlined in last month's *Danby News*.

In its formal review of the proposals, the county planning department's letter states "We are impressed with the development of the open space conservation strategy presented in these subdivision recommendations. They may be a model for other communities considering strategies to preserve open space in Tompkins County and beyond." Come check it out!

Currently the group is finishing up proposed changes to the zoning ordinance. Next will be consideration of an affordable housing ordinance and an erosion and runoff ordinance aimed at protecting both land and water resources. Meetings are at 7 pm on the second and fourth Wednesdays of the month at the Town Hall. The group welcomes participation in the work, and the broader the participation the greater the likelihood that everyone's concerns will have already been addressed when the results are sent on to the Town Board for formal consideration. Not only does this help assure passage, it also ensures that your concerns are given careful and complete consideration. Why not join us on March 9 and 23? Submitted by Joel Gagnon

# NO ROAD PARKING

Local law No. 1 of 1990 allows for the emergency towing of any vehicle parked or abandoned on any roadway within the Town of Danby that hinders the ability of Danby, or other government personnel, to respond to a snowstorm, flood fire or other occurence requiring a swift response. Towing is at owner's expense.

## DEAD DEER REPORTS

To report a dead deer on a Town of Danby roadway, please call the Danby Highway Department at 272-9169. Notify us promptly, so that the deer may be picked up as quickly as possible. Please leave this info: your name, nearest house number to deer, the location of the deer itself (in ditch, near mailbox, etc.) and most importantly a call back number in case we need more information. We will call in the report to the proper highway department (state, county or town). Town & county usually pick up deer the same working day; the state may take up to 24–48 hours. Deer are not picked up on weekends, but you may leave a message on the answering machine anytime.

# SNOW'S STILL HERE!

Please keep these safety tips in mind this winter.

- Local law No. 1 of 1990 prohibits parking on roadways. Please park your vehicles in your driveway. This will allow safer and quicker snow removal from our roadways.
- Please don't place garbage cans or recycling bins in the way of removal equipment. The snowplow wing can miss hitting these items if they are kept far enough back from the shoulder of the road. We do not want to hit them or place snow in them. We will not cross the centerline of the road to avoid hitting these items, possibly endangering other motorists or our road crew.
- Lastly, do not tailgate snow removal vehicles. Snow and ice covered roads can present unknown hazards.

These reminders are for everyone's safety. Please do your part to have an accident-free winter.

# PARK ORGANIZATION MEETING

All Danby residents are urged to attend the public meeting of the Danby Community Park Association at the Danby Town Hall on Thursday, March 24 at 7: 30 pm. The board and officers elected after the Association was organized as a not-for-profit in November 2001 have been collecting information on community needs and wishes, available funds and planning assistance, but have been unable to proceed with development or even be sure we could have a park until land for a safe entrance could be obtained. Unfortunately this has taken literally years. In the meantime, a number of grants have been awarded to the Danby Park project: \$109,000 in a matching grant from the New York State Department of Parks; \$25,000 of New York State funds from State Senator Seward for the planning of a community building; \$3,500 from the Tompkins Trust Company Robert S. Smith Award for Cornell landscape architecture student cooperation in the planning of park facilities; as well as a grant of \$500 from the Ithaca Rotary Club for the purchase of materials to develop picnic areas, \$500 from Cornell Cooperative Extension for plantings, and significant legal and other planning services and land acquisition funds from individuals, local firms, and Cornell University departments.

This spring we can finally start work on developing the recreational facilities for the park, and the planning phase of a Danby Community Center building. Now we are anxious to have renewed public input, to get Danby residents' ideas for recreational facilities and the needs to be met by a community center building, to expand the DCPA board to represent various groups and interests in the community, to renew contact with the volunteers who have already offered their help, recruit new volunteers, and establish standing committees to bring the park and community center building to fulfillment. All Danby residents 18 years of age and older are members of the Association, and have a voice and a vote in the election of their representatives on the park association board and in the actions to be taken to develop the park and community center.

The map (opposite page) shows the land now

available for the park and building, and the tentative location of various facilities. Detailed maps will be displayed and discussed at the meeting A proposed schedule of development tasks and lists of possible volunteer activities will be put forward and suggestions welcomed. The plans, based on community questionnaires and previous public meetings, include a soccer field, a baseball diamond, playgrounds for younger (1–6 years old) and older (7–12) children, picnic areas with facilities for grilling, woodland trails, and a building with meeting and banquet facilities, expanded community library and computer space, game and hobby areas, and possible child care room.

The Association will be meeting twice a month on the second and fourth Thursdays at 7:30 pm during the next months, when many aspects of the plans will be discussed and moved forward. 2005 can be a great year of progress, with the help of talented and professional volunteers, toward a splendid new community resource of which Danby can be proud.

# DANBY PARADE SAVE THE DATE & JOIN IN!



# COUNTY REP FRANK PROTO REPORTS

As you no doubt read, the TCAT service to Danby and Caroline has been revived under the new structure. Ridership is improving, the safety plan was approved, and the new General Manager Joe Turcotte will take the reins in March. Thank you for your continued support.

For those of you that received adjusted assessments recently and want to review them with the assessors you should call them as quickly as possible or as close to March 1<sup>st</sup> as possible at 274-6456 and make an appointment. These informal reviews will take place into March. Don't forget to submit your Ag Assessment paperwork prior to April 1, 2005!

In an effort to bring back some fee money to the county an effort is being made to go after the Universal Fund. Each telephone line "contributes" a fee based on your long distance telephone calls. The monies can be used for library and school internet services, health care, poverty level recipients, and the phone companies themselves. It is estimated that Tompkins County residents pay approximately \$1,000,000 annually into this fund but have only received a fraction back—\$92,000 in 2003! Check your bill; it's definitely a hidden tax. I'd be glad to give you additional information, or call Karen Fuller (274-5434) at the Legislature office. A second onerous fee is NYSEG's transition surcharge—more on this to follow.

The Board of Health has been asked to issue an opinion on banning all open burning except that which is agricultural in nature. Though the current sanitary code has restrictions, this ban would supersede the current code. I'd appreciate your comments.

The Agriculture and Farmland Protection Board is reviewing the county's protection plan and will no doubt submit some revisions. I'll keep you posted on this.

Currently we're reviewing the Governor's proposed budget and its local impacts. Health care services seem to be hardest hit, but nothing is final yet.

Our Strategic Planning Committee continues to review and identify items we'd like to concentrate on over the next several years. Efficiencies must be achieved in order to keep costs in line.

Dandy resident and firefighter Andrew Dunnick received the county's Distinguished Youth Award for his outstanding contribution to the community. His fine example is recognized by his school as well as his neighbors.

Appointments to advisory boards are always tough to fill due to the needs of various boards. Recently, the length of time in the county and community awareness of the applicants have been topics of discussion. Professionally well-credentialed individuals may not have any idea what the community needs may be, and may unknowingly negatively effect an issue's outcome. This item will be a constant topic since no one wants to discourage involvement.

Empire zones and their tax consequences, along with all tax abatement programs, will be receiving attention this year. A complete review has been requested.

A study and review of the community's policing needs is underway. Caroline Supervisor Don Barber has agreed to chair this ad hoc committee at the request of the Intermunicipal Task Force.

# TOMPKINS COUNTY YOUTH OF THE MONTH

Congratulations to Andrew Dunnick, a member of the Danby Volunteer Fire Company, on being named the Tompkins County Youth of the Month. Andrew has an outstanding record. He is on the academic honor roll at Ithaca High School, and he has been inducted into the National Honor Society. He is the Vice President of this year's senior class. He is also Co-President of the Model United Nations Club, captain of the varsity tennis team, a writer for the student newspaper, and an eagle scout.

All the same, Andrew has received this award primarily for his service to Danby as a member of our fire company. Our county representative Mr. Frank Proto emphasized these achievements in his speech before the Tompkins County Board of Representatives in January. In December, for example, Andrew rescued one of our neighbors through CPR. The day after Christmas, he was among the first firefighters on scene to attack a fully involved structure fire. And just last week, as though to confirm his recent award, Andrew helped to stop a house fire in Danby as nozzle-man on the advanced hose line.

Andrew has already completed the training to be an interior firefighter, and he will be authorized for these operations when he turns eighteen on March 6. This notice is just to say how very proud we are of Andrew's accomplishments. He exemplifies the spirit of community, and he is helping to carry the proud tradition of the volunteer fire service into the future.
