BOARD PASSES OPEN SPACE LEGISLATION—ADJUSTMENTS LIKELY

On May 11, the Town Board passed the first round of legislation proposed by the Comprehensive Plan Implementation Task Force. The vote was unanimous to change the Zoning Ordinance and Zoning Map; Norbert Nolte dissented on the changes to the Subdivision Ordinance, which therefore passed 4 to 1. Mr. Nolte's "no" vote was based on his belief that the formal delineation of conservation areas as provided for in subdivisions in the Low Density Zone is an unreasonable restriction of property owners' rights. This belief was shared by many who commented at the public hearing. The majority on the board thought it best to pass the legislation and look to adjust its provisions in the second round, which the task force is currently preparing.

As task force chair, I invite those who are unhappy with the components of this legislation to join in shaping the additions and adjustments that will be in the second round proposals. I realize that to some of you any land use regulation is distasteful and you have

chosen to distance yourself from the process. The more people do that, the less palatable the final result is likely to be, since what comes out of the task force is shaped by those who take part. Not everyone can come to the task force meetings, I know. If you have email, you can join the list of those who have asked to be kept abreast of task force-related activity. This is not a formal list-serve; anyone can "reply to all." Just send me an email at <joelpgagnon@hotmail.com> and I will put you on. To broaden participation, and because the issues are complex and deserve careful scrutiny, I will be using the task force list between meetings to explain the options before us and encourage feedback and discussion. We can all profit from engaging in an honest back and forth on these approaches. Please consider joining in.

TASK FORCE UPDATE

The next Comprehensive Plan Implementation Task Force meeting is scheduled for 7 pm. Thursday, June 9, at the Town Hall.

The May meeting was spent listing all the possible changes and additions to the already-passed first round of open space protection legislation. There was considerable discussion of the advantages and disadvantages of each, but the sense of the group was that we all needed to think about them more before we could be comfortable including them in a recommendation to the Town Board. To help that thought process along, and to encourage wider participation in the deliberation, I will use the task force list to explain each option and provide an opportunity for between-meeting comment.

The options that are on the table so far include:

- 1) Abandoning the delineated conservation area approach and instead using some sort of conservation subdivision procedure that would simply exclude unbuildable areas at the outset (very steep slopes, wetlands, flood plains, and possibly stream corridors) and provide incentives to keep houses off tillable acreage.
- 2) Expanding the options for "ministerial" lot creation, where a landowner can subdivide by permit without having to go to the Planning Board. Some possibilities in this category include allowing very large lots,

or small lots restricted in some way, based on frequency of creation or in exchange for not developing another lot.

3) Increase flexibility in lot placement by allowing frontage lots to be “compressed,” with reduced frontage and area so they can be grouped together on less frontage, and allowing “conservation” flag lots. Flag lot options include substituting flag lots for frontage lots to leave some frontage undeveloped and allowing flag lots in exchange for giving up the right to develop some interior land.

4) Using phasing of subdivision plans to encourage landowners to plan ahead. This could include a “sun-set” provision that would apply if the phasing did not come to pass as agreed (approval would expire).

Do you have other ideas that I have not mentioned? The objective is to discourage sprawl and protect open space as painlessly as possible using a combination of regulatory and non-regulatory approaches. The non-regulatory approaches are being pursued simultaneously (see additional article on that). If you think you have a fairer or easier way to accomplish the objective, please join the planning effort. BOARD URGES PASSAGE OF “PRESERVATION ACT”

The Town Board passed two resolutions in May directed at enabling a non-regulatory approach to protecting land from development. The first one was a resolution of support for legislation pending in Albany (A. 6450/S. 3153) that would enable towns to create community preservation funds to purchase land or interests in land.

The second resolution passed by the Board urges our sister municipalities in Tompkins County to support this legislation as well.

Why did the board take this action? When the Comprehensive Plan Implementation Task Force held its community meeting to get a sense for which open space protection strategies to pursue, there was strong support for the non-regulatory option of purchase of development rights. A committee was formed to investigate the feasibility of that option for Danby. That committee came back to the task force with the recommendation that a local conservation commission be formed to pursue acquisition of development rights and that the town pursue a real estate transfer tax to help fund it. That tax has been used very successfully at the eastern end of Long Island. The legislation cur-

rently pending in Albany would enable towns across the state to use that same tool. The board would like to be able to propose its use in Danby, hence the resolutions.

WHAT IS A REAL ESTATE TRANSFER TAX AND HOW CAN IT AFFECT DANBY?

A real estate transfer tax is a tax paid by the buyer when real property is transferred from one owner to another. In 1996 the state legislature gave East Hampton, Riverhead, Shelter Island, Southampton and Southold on Long Island permission to institute a 2% transfer tax which was to be used for "community preservation." Community preservation is defined in the law as "a) establishment of parks, nature preserves, or recreations areas; b) preservation of open space, including agricultural lands; c) preservation of lands of exceptional scenic value; d) preservation of fresh and saltwater marshes or other wetlands; e) preservation of aquifer recharge areas; f) preservation of undeveloped beachlands or shoreline; g) establishment of wildlife refuges for the purpose of maintaining native animal species diversity, including the protection of habitat essential to the recovery of rare, threatened or endangered species; h) preservation of pine barrens consisting of such biota as pitch pine and scrub oak; i) preservation of unique or threatened ecological areas; j) preservation of rivers and river areas in a natural, free-flowing condition; k) preservation of forested land; l) preservation of public access to lands for public use including stream rights and waterways; m) preservation of historic places and properties listed on the New York state register of historic preservation ordinance or law; and n) undertaking any of the aforementioned in furtherance of the establishment of a greenbelt." Since the law was passed, these communities have used this money to preserve over 2,500 acres.

Because this experiment was so successful, many communities have petitioned their legislators to be allowed to assess a transfer tax of up to 2% in their communities. Consequently, a bill, commonly called the Community Preservation Act (A. 6450/S. 3153), is now being considered by both chambers of the state

legislature. It is co-sponsored by many legislators, including Barbara Lifton.

How would this tax be assessed?

Housing sold for less than the median price would be exempt from the tax in order to minimize the effect on affordability; housing sold for more than the median would be taxed on only the value exceeding the median.

What are the positives of this tax?

The positives of the 2% transfer tax are that it affects only the buyer of real property, it is assessed only on real property that is transferred, the buyer is allowed a credit against the tax, the tax provides towns with money to preserve open spaces (individuals who want to preserve their land but can't afford to donate it can be financially compensated for either selling their land outright or selling its development rights).

What are the negatives of this tax?

The major negative is that the transfer tax becomes another one of many taxes and fees a buyer must pay when they buy real property. It would increase the cost of higher-end housing. (This is likely to be offset by the credit buyers would receive on their taxes, though.) In addition, many land developers object to the tax because it decreases the availability of land. Unless other measures are taken to make more land available, the reduced availability would result in increased land prices and add to the cost of constructing new houses.

What is the public participation component of this law?

The townspeople must vote by referendum to adopt the assessing of the transfer tax in their town. If the majority of voters want to establish the tax, the town must then establish a dedicated fund for the money.

DANBY HISTORY NOTES

THE SPRING HOUSE

As you drive along our countryside you're liable to spot an occasional small short roofed building situated near a stream. This odd little structure, in most cases, was at one time a spring house. In the days before refrigeration this small one room building was used to keep food cool.

Construction

Ideally, the house was built over a spring where cold water bubbled up from the ground. In cases where no spring was available a small stream was often diverted from a nearby creek and directed through the building. Spring houses, whether simple wood structures or extravagant cobblestone or brick ones, all served the same purpose, that of cooling. The building was generally five feet square. Sidewalls were approximately three feet high and the peak of the roof was four feet high. The door was wood and the interior walls were lined with shelves well above the water level. There were openings at the base of the building at opposite sides of the structure large enough for a spring or stream to run through. In the center was a trough. The trough sat long ways in the stream. It was usually three feet in length, approximately six to seven inches deep and twelve inches wide. A three-inch wide trench was cut from the bottom and three inch square holes cut from the bottom edge of the ends. These openings allowed the water from the spring or stream to flow through the trough, continuously changing the cooled water. The high sides kept the contents from floating away. A cement trough had the advantages of being cooler by nature and more long lasting than wood.

Uses

The shelves of the spring house were used to store pies, baskets of potatoes, onions, fruit and other garden produce. Wire baskets held eggs. Airtight jars and crocks containing milk, cream, butter, cheese, tea, lem-

onade, etc. were placed in the trough. In the summer the spring house "was always 20-40 degrees cooler than anyplace outside."

This simple little structure, the spring house, made life easier for our great great-grandparents. Just imagine our using it today.

TO REPORT A DEAD DEER ON THE ROADWAY

To report a dead deer on a roadway in the Town of Danby, please call the Danby Highway Department at 272-9169. It is important to notify us as soon as possible so that the deer can be picked up promptly, avoiding further problems such as decay and destruction by dogs.

Please be sure to leave the following information: your name; the nearest house number to the deer; the location (in ditch, driveway, near mailbox, etc.); and most importantly, a callback number. We may need to call you back for further information. We will then call in a report to the proper highway department (state, county or town). The town and county departments usually take care of deer in their roads the same day. The state contracts out this service and may take 24 to 48 hours for pickup depending on when they are notified. Deer are not picked up on weekends, although you may leave a message anytime on the answering machine.

NO PARKING ON ROADWAYS

Local Law No. 1 of 1990 allows for the emergency towing of any vehicle parked or abandoned on any highway within the Town of Danby that hinders the ability of Danby, or any other governmental agency, to respond to a snowstorm, flood, fire, or other occurrence requiring rapid response. Towing is at the owner's expense.
