# JUDITH KELLOCK SONG RECITAL SATURDAY, AUG. 27, 3:00PM DANBY TOWN HALL

The next concert in the Danby Community Council's Concert Series features soprano Judith Kellock and pianist Blaise Bryski performing songs of Samuel Barber. The program "Everything But The Hermit" includes all the songs written by American composer Samuel Barber (1910–1981) except the Hermit Songs. Like the rest of his music, these songs defy categories and represent a colorful, fascinating journey, with texts ranging from Hopkins to Housman, Rilke and Joyce.

Judith Kellock is an extraordinary musician and an electrifying stage presence. She has been described in the press as "a singer of rare intelligence and vocal splendor, with a voice of indescribable beauty." She has performed all over the world (including Danby) in repetoire ranging from Bach to contemporary classical music, opera to chamber music. She has recorded for several labels and is a founding member of Ensemble X. She is on the performing faculty at Cornell.

# TASK FORCE UPDATE

The Comprehensive Plan Implementation Task Force noted with sadness the death of Carl Steele, a regular participant in our work, and passed a resolution of appreciation to send to his mother.

#### OPEN SPACE PROTECTION LEGISLATION:

The task force looked at a map of the best soils in Danby. We found that there is a little bit of class I, a little more of class II, and quite a lot of class III. Class III received the most attention, since its suitability for agriculture is heavily dependent on management. When well cared for using cultural practices that minimize erosion, improve drainage, and maintain and enhance organic matter content, soils in this class can be quite productive. Sue Beeners suggested, and the task force embraced, that we provide an incentive to avoid building on class III (or even IV or V) soils that have benefited from good management and consequently are being actively farmed. We will thus propose to the Town Board and Planning Board, once we draft the language, that landowners willing to set aside and protect Class I and II soils, or soils in other classes actively used for agriculture, be given a density bonus. For every 5 acres of such soils protected, they would be given an extra lot. Besides encouraging farmland protection, this provision would encourage clustering of the residential lots created.

We next began to look at alternatives to the 60% conservation area provision in the legislative package passed in May by the Town Board. There was considerable discussion of whether to exclude unbuildable area (very steep slopes, wetlands, and flood plains) when

calculating the lot entitlement for a parcel. The Planning Board suggested that these unbuildable areas be included, but that the Planning Board be able to reduce the allowed density when warranted. But when might that be? Excluding such areas is the most common practice. We decided to ask our county planning department support person to explore for us what others are doing before discussing further what to propose.

On the question of whether to abandon the delineated conservation area approach altogether, the group briefly considered a suggestion that the approach be made optional so those attracted to its benefits could use it and those who don't like it wouldn't have to. Sue Beeners (who has to administer whatever gets adopted) objected that the complexity involved in doing that would be burdensome for her office to handle. Others added that too many options would be confusing. While flexibility has generally been seen as a good thing by the group, its sibling, complexity, has not. We agreed to ponder this for another month and will return to it next time. My sense of the group is that we are leaning away from retaining this as an option. The alternative we will likely include in any event will probably be called "Flexible Subdivision Rules," or something like that. More on that next month.

The next task force meeting is at 7pm on August 11, at the Town Hall. How to broaden participation in that group (including the possibility of moving the task to the Town Board level or assigning it to the Planning Board) is a topic of discussion among many of us involved. I will report how this gets resolved as soon as we come to agreement on it and I will post it to the list of people who have asked to be kept abreast of task force activities (as well as report it in the Danby News). If you are not yet on that list but would like to be, send me an email and I'll put you on.
