## MORE ABOUT LYME

There are simple things, beyond wearing appropriate clothing, to minimize the chance of getting bitten by deer ticks. Some use manufactured chemical repellants that contain the powerful insecticide *deet*, but *deet* is not healthy for people either, as it's absorbed by the skin. One non-toxic tick repellant is a garlic oil preparation meant to be applied to the ground (your yard) once a month [[mosquitobarrier.com](http://mosquitobarrier.com)].

A repellant meant to be applied to skin, clothes and other items is made out of red cedar tree oil. *Best Yet* is available from [[cedarcide.com](http://cedarcide.com)] (I've ordered it.) It's also for mosquitos, bedbugs, and other biters and is supposed to be non-staining. I apply it to a piece of cloth that I put under me when I sit on a log or the ground. I also plan to apply it to clothing when I'm on an outing.

Another garlic oil product, from [[garlicvalleyfarms.com](http://garlicvalleyfarms.com)], is meant to be given daily to dogs, to prevent ticks from getting on them. The natural sulphurs in the garlic disturb ticks so they stay away, while supposedly killing the young ticks. Feeding dogs this oil from garlic is said to prevent worms, too. The Cedarcide company also carries a product designed for dogs. They claim it successfully replaces the unhealthy insecticidal application that many people put on dogs to keep ticks at bay.

There's anecdotal accounts about how eating enough raw garlic—daily—keeps ticks away. One friend described how this hadn't worked for her for mosquitos, but did work *down south* where ticks were so abundant she could see them crawling on the ground. She told me that her partner was a tick favorite until he started eating garlic regularly! ❀

# TOWN OBSERVER

A short extract from Joel Gagnon's Broader View articles

## July Town Board Meetings

**Internet Access**—This topic came up in a variety of ways during the July Town Board meetings. Supervisor Ric Dietrich reported that he is putting together a coalition to jointly apply for Federal Stimulus funding for a regional broadband network. This effort is being driven by the way the stimulus funds are being distributed. Only large-scale projects are being funded, creating an incentive for collaboration. Dietrich said he was arranging a July conference to try to get potential players on board.

Haefele TV, which currently provides DSL service to a small part of southern Danby, apparently feels that it would not make sense to expand further north. Haefele apparently is willing to provide coverage in Danby from the Ithaca side, but do not want to take the initiative in acquiring the rights to do so from Verizon.

Time-Warner Cable, citing the expense, has done little to extend its cable network to rural parts of Danby. Danby's cable franchise, granted to Time-Warner, expired years ago and has been simply extended on the same terms ever since. Guy Krough, an attorney for the Town who attended the meeting, suggested that collaborating with other Towns during franchise negotiations might give the Town the leverage to negotiate service expansion. Dietrich was asked by the Board to approach the Tompkins County Council of Governments with a proposal to negotiate collectively, with the costs shared.

**96B Signage**—Robert Roe, who lives next door to the Town Hall, reported that an errant driver had motored off of the highway and crossed nearly 200 feet of his lawn, destroying his mailbox. Apparently, the passing lane (intended to provide safety for cars positioned for a left turn onto Hornbrook Road) ends abruptly, with no warning, leaving speedy vehicles pointed at his lawn.

This is the second time a car has run onto Roe's lawn; the first time, his car was hit and totalled. Roe asked the Board for help in dealing with the situation. Supervisor Dietrich indicated that he would request some sort of signage from the DOT, hoping those signs could be added to the existing plan for re-signage related to the new 40MPH speed limit.

**Legislative Snags**—Expressions of disbelief greeted the news that the Town's attorney for legislative matters

had not been consulted prior to Town Board's consideration of its *Right to Engage in Agricultural Activity in Danby* law, or the changes to the Town's subdivision regulations.

When the attorney was asked to send them on to the Secretary of State for filing, she remarked on several issues, most notably the Town Clerk's failure to properly provide legal notice of public hearings. The notice went into the paper five days before the public hearing, instead of the required minimum of ten days. The board will repeat the hearing and action on the law, on Monday, September 7, at 6:30pm.

The attorney also noted differences between the Danby Right-to-Farm law and language in NYS Ag and Markets law. The Comprehensive Plan Implementation Task Force reviewed the attorney's concerns at its meeting (which took place between the agenda and regular Town Board meetings) and concluded that those concerns had been adequately considered (the attorney was not aware of the discussion that had taken place in committee). The Task Force recommended that the attorney be asked to file the law as passed, as she had indicated she would do, if asked. The Town Board agreed and instructed the lawyer to proceed with the filing.

**CSEA Negotiations**—The contract with the union representing the highway department workers expires at the end of the year. Negotiations are soon to get underway. Guy Krough, an attorney with negotiating expertise, has been hired by the Town to assist and advise the Board. The Board voted to designate Supervisor Ric Dietrich to negotiate on its behalf.

**Other Actions**—The board authorized the Supervisor to sign the contract with Danby Community Council (the DCC's board had similarly authorized the Council president, Bob Strichartz, to sign it). A revised resolution supporting the creation of a County health insurance consortium was also passed. It is substantially the same as last month's but worded better.

It was reported that evaluation of the West Danby Water system is underway. A committee is being created to explore options for erecting a salt shed for the Highway Department; Gene Beavers volunteered to be on it. There was a discussion about whether the templates for local laws being prepared by the County Planning Department to cope with the impacts of gas drilling will cover more than road issues and, if not, how and whether the other issues can be addressed collectively. Marjorie Bitzer is working with Kathy Halton to explore what needs to be done. ❁

## SUPERVISOR'S UPDATE

The theme of my update item in last month's Danby News seems to have set a theme...and attracted interest. I talked about gas drilling, emergency management, community get-together, and NYSERDA energy audits.

The Town's position on gas drilling is to collect and to present all the information that would affect Danby residents, particularly the effects on the residents as taxpayers.

In July, the Planning Board will hear presentations on storm water regulations related to *all* building sites for Danby. This will, of course, cover potential issues related to gas drilling regulation. The agenda also includes a presentation by an attorney, talking about gas leases, water rights, mortgages, and sale of property.

We are working with the County on road classification material, a.k.a. "Templates," that the Town can use to help protect our roads. Danby has a task force that is taking charge of oversight on issues related to gas drilling.

After a series of discussions about emergency management, the Town has decided to prepare recommendations related to a possible pandemic affecting the Town. If you would like more information on this issue, or want to participate in our meetings, please feel free to contact me with your interests and/or questions.

The Town has also decided to participate in a program which is intended to lead to a broadband (Internet) build-out in Danby. I am sure you will have seen more of this in the news before this article reaches your mailbox. If you would like an update on where we stand, please contact me.

The NYSERDA energy audit of the Town Hall and Highway Barns is complete. The Town Board will discuss implementation of the resulting recommendations during its August meeting.

The Town has several potential vacancies (Highway Department, Town Planning, Board seats, and winter shoveling). All interested participants are encouraged to turn in resumes to the Town.

## TRASH TALK IN DANBY

A first offense can bring a maximum fine of \$350 and/or up to 10 hours of community service. A second or subsequent violation, can bring a maximum fine of \$700 and/or up to 15 hours of community service. Please be a good steward of the town in which you live by 1) not littering, 2) picking up litter that you find and 3) reporting any littering you witness to the county sheriff's department.
