Gas Drilling Task Force

On December 8, Danby's response to the draft of the Supplemental Generic Environmental Impact Statement (dSGEIS) was sent to the New York State Department of Environmental Conservation (DEC) by mail. The response, prepared by volunteers from the Task Force, was a professional and impressive document. It was approved by the Town Board before it was sent and, hopefully, the Planning Board will approve it as well. We are waiting for a response from the DEC to many of its points, and will be writing about that when it comes in January.

The Town of Danby has been and will continue to work on several ordinances intended to help protect Danby from some of the more glaring problems that other localities have experienced with gas drilling:

- road ordinances that will apply to trucks driving through Danby and to trucks that are going to and from drilling sites
- stormwater ordinances dealing with run-off water and the protection of groundwater
- culvert and road cutting permits
- light and noise ordinances.

The beginning of the year will feature several public hearings, allowing the public to have input into these ordinances. Watch for info about these hearings on the Town web site [town.danby.ny.us], in local papers, and in the Danby News.

In late November, several members of the Task Force attended a meeting with Walter Hang. We discussed ways to encourage Governor Paterson to withdraw the dSGEIS because of the many questions about its efficacy, mainly the regulations' ability to protect drinking water. Walter runs a company, Toxics Targeting, which uses government databases to investigate toxic spills. He presented a range of problems that have occured at conventional vertical wells in New York State...that have not been dealt with adequately by the DEC. Toxics Targeting, a local company, has already collected more than 7,300 signatures on a petition to Governor Paterson,

The Task Force continues its work on other topics:

- pipelines for the transmission of natural gas and their impact on the local environment
- regulations about wastewater that is generated by the drilling process
- an demonstration in Albany on January 12 and a meeting with legislators there to let them know our concerns about drilling's impact on our town.

Early in the year, Cornell's Water Law Clinic (including Cynthia Bowman and students Katarina Barquet and Erin McLeod, who helped us a great deal with our

Snafu at Post Office: Danby Area News Lost in the Mail

Sometimes, when our expectations have reached a high point, we have to be prepared for a setback. Even so, none of us who work on the Danby News expected the snafu level achieved by the delivery of the December issue (if you're not old enough to remember the word "snafu", google it).

Here's a snapshot review of our delivery process: we hand-carry mailing flats full of the Danby News to the Ithaca post office. The flats are presorted and labelled with their destination post office names. We're good; the post office always gets them in time to be delivered to you before the 1st of the month.

About two-thirds of the issues are addressed to "Postal Patron" and the Post Office delivers them to every mailbox on specific carrier routes. The remaining third of the issues are individually addressed to residents whose homes are *not* on one of the carrier routes.

"What?" you ask. Aren't all homes on one carrier route or another? Danby is an orphan created by the Post Office's constant cost cutting. It has no post office of its own and its geography is divided among five (count 'em, five) different ZIPcodes; worse, four of the five have the 148- region prefix in common, but the fifth (Willseyville) is part of a Binghamton-based region. As a result, there is no set of carrier routes that covers all of Danby, or even that covers *exclusively* Danby addresses. It's a blivet (yes, look it up).

By now, we're used to hearing from residents in Willseyville, who receive issues a week later than most others, from residents in Spencer who don't get issues in spite of being on a carrier route we target, and from Ithaca-based residents who miss the occasional issue. We seldom hear from Newfield residents (in theory, *all* of them receive individually-addressed issues) or from folks on the Brooktondale delivery routes (maybe they don't know about the Danby News?).

OK, now you have the picture. Imagine the surprise when the Ithaca carrier showed up in Town Hall, early in December, to drop off two flats—perhaps 400 copies—with the com-

Locally-owned Business Passes a Milestone

Supervisor's Update

It's December and, as I think about the past year, I am looking back over Danby News articles. Did I leave you wondering whether I got all my wood out? Well, no, I didn't.

Can I mention elections in this paper? They are a sensitive issue for some, but, for all of you who came out to vote in November's Town election and

in the December Fire Department elections...the Town thanks you.

In retrospect, consider-

ing the Town's future and how elections here and around the county turned out, it was surprising how close many of them were. It's clear that each and every person has a voice in determining who represents you.

Now, as the newly elected officials present themselves to begin their tenure in office, I am asking the questions, "Who are these people you elect? What do you expect from them?" These are my co-workers; sometimes I have a hard time keeping up with them, but I often see them working on weekends and late into the night.

When I stopped by the Town Hall the other night to pick up some material, the place was packed for Tuesday's night court.

Last Sunday night, I got a call from a resident who was having trouble getting home. A call to the Highway Department found them still out on the roads, and they promised to swing by and lend assistance. In the background I could hear the town siren going off and knew there were people jumping into turn-out gear.

When I stopped to donate clothing at the drop-off center, the Church parking lot was full for Food Pantry day.

From the inside, looking out, the Town looks very different than the brief snapshot one might see while driving by, in the same way that a person's body gives little clue to the complexities of what goes on in the inside.

What is it really all about? What gets accomplished in any given week, what is really going on in your town? Do people want to know? We have our lives and our jobs, families, school, shopping, Church, and even all kinds of bills to pay. We worry, we fret, sometimes we smile, and sometimes we laugh. Sometimes we talk to our neighbors.

On January 4, elected officers, staff, and committee chairs will meet at the Town Hall to begin a new year. We will start by taking care of some business, and then have a conversation about tasks and responsibilities for

the upcoming year. The conversation will include some of the topics that we did not fully address last year.

I hope you will attend...or send in your thoughts. What tasks would you like to see us address this year?

Our new year conversation will be the first of many that we will have about our town and how it is working. There will be conversations and suggestions about how we can do a better job of dealing with all of the realities on the inside--the ones you usually do not see.

How to make us more transparent and more responsive. We'll talk about better ways to let the public know about what's going on: publicizing agendas prior to meetings and publishing minutes promptly afterward. We'll plan to write grants for housing rehabilitation, broadband development, and energy efficiency. 🕏

November Planning Board Meeting

During its November meeting, the Danby Planning Board unanimously approved Mike Hovanec's proposal, to replace of the storage buildings at Fort Locks Self Storage Mall with a slightly larger, climate-controlled building with interior access. No one spoke at the public hearing that preceded the board action; Board comment was minimal and uniformly supportive.

During its "privilege of the floor" period, the Planning Board also heard about a proposal to sell a 4-5 acre lot-outside the 30-home cluster--in White Hawk Ecovillage. The lot would be alongside the common driveway leading to Danby Road. Joe Italiano, speaking for White Hawk, indicated that the need for a cash infusion has forced them to consider a lot in the middle of what was designated (in the development plan) as land reserved for agriculture. Unlike lots in the village cluster, which are rented in long-term leases, this lot would be sold outright.

Board discussion centered on what is allowed within the scope of the planned development district that the Town created specifially for the 30-home village. It was opined that adding a 31st house on a separate lot probably would not fit within the district plan, and would require modification of the original approval. Substituting this lot for one of the 30 in the village cluster might, arguably, be done with a modification of the site plan instead of reapproval. Italiano thanked the board for their input and said he would bring the information back to the white hawk decision-makers for them to contemplate further.

The Board also considered the "stormwater legislative program" being advanced by the Town Board. The Board affirmed the Town Board as lead agency in environmental review and recommended a negative declaration of environmental significance. It additionally recommended that the three laws be adopted.

December 2009 Town Board Agenda Meeting

A lot of hard work by the Gas Drilling Task Force came to fruition on December 7, when the Danby Town Board embraced its report and made it the Town's official comment on the NYS DEC dSGEIS. The letter of conveyance also requests that the dSGEIS be withdrawn and reworked to address the shortcomings identified by the Task Force (and many other groups in the region).

Among the concerns cited is that the dSGEIS permits large-scale industrial development to take place with very few local mechanisms to mitigate its impact. Local governments would be tasked with water quality environmental monitoring, without an accompanying funding source. The cumulative impacts of multi-well development are largely ignored, and the DEC lacks the human resources to monitor and enforce the regulations.

The Task Force also proposed a resolution for town board consideration that would request of Governor Paterson that he withdraw the dSGEIS. (The resolution was approved by the Board on December 14-editor).

The Town Supervisor, Ric Dietrich, announced that the bundle of local laws to implement the stormwater regulations, originally scheduled for a public hearing on December 14, needed to be withdrawn and reworked. Little was said to indicate the nature of the inadequacy that derailed consideration. Dietrich indicated that a reworked version would appear for Board consideration at a later meeting.

Another package, to address potential highway impacts, is also being worked on. Dietrich reported that, like the stormwater regulations, a bundle of laws would be required to address all the highway issues.

The Board made good on its promise to respond to Mike Hovanec's informal proposal for added development on Muzzy Road, presented in November. Hovanec had proposed an additional 2-unit apartment on a 5-acre parcel where a 2-unit apartment already exists (the existing construction also had required a zoning variance). In November, Dan Klein had indicated that he was unsupportive and, at this meeting, Dietrich and Leslie Connors both indicated that they would not support the action. Gene Beavers was silent on the matter and Joe Salino was not present.

Nancy Medsgar was interviewed for the vacant position on the Board of Zoning Appeals that was created by the resignation of Ted Jones, and then appointed. Medsgar, a Marsh Road resident, said she had been considering getting involved in some way and decided to apply for the position when approached by Dan Klein. She spoke of her experience dealing with the appeals board in Cortland, where she owns property.

That experience sparked her interest in the process and in serving the public. The appointment was by unanimous vote.

Ed Marx, the Tompkins County Planning and Public Works Commissioner, requested that the Town Board indicate its support for a grant application to the U.S. Department of Energy, to establish an energy efficiency financing program. The fund created by the grant would create a loan pool from which property owners could borrow to make energy efficiency improvements or to install renewable energy systems on their buildings. Loan repayment amounts would be equal to or less than the savings in energy costs and would be made over a number of years.

The need for quick response (Marx asked for action by December 10 so the county could make the December 14 application deadline) led the Board to act at this meeting. Following comments by both board and audience indicating strong support, a letter was unanimously approved.

Supervisor Dietrich updated the board on the contract negotiations with the union representing the highway workers. He indicated that the negotiations have now reached the difficult issues of wages and benefits, and that progress is very slow.

Town Clerk Carol Sczepanski reported that the town has received a new MIA flag from the Veterans of Foreign Wars in Ithaca, to replace one damaged in the course of painting the Town Hall.

Also, three new benches have been installed around the gazebo (next to Town Hall, courtesy of the Bicentennial Committee. Sczepanski mentioned that the Town still has several bicentennial throws for sale (\$35; available at the Town Hall).

The Board set the date for its year-end meeting: 6:30pm on December 28.

Danby State Forest News

Ticks

On the first day of deer shotgun season, two hunters on Bald Hill Road, just south of Comfort Road, reported to me that they had encountered a number of ticks, though they didn't know what kind, and that the ticks had made their way past their camo pants and long johns right onto their legs and groin area. I was surprised at this news and Emailed DEC forester John Clancy to see if he had encountered any ticks.

Yes, Clancy responded, in 2009 he had encountered, for the first time, *Ixodes dammini* ticks in the Bald Hill Road area. Ixodes dammini are the ticks known for being vectors of *Borrelia burgdorferi*, commonly called Lyme disease.

Ticks, like mites, spiders, millipedes, and centipedes, are arachnids, not insects. Therefore, they don't have wings and don't fly. They get around by hitchhiking on warm-blooded animals (humans, dogs, coyotes, deer, etc.). The male Ixodes dammini tick is black and very small (about the size of a coffee grain), and is able to crawl through certain types of fabrics. The female is about twice as large but still small and brown.

An Ixodes dammini tick doesn't always carry the spirochete that causes Lyme disease, but two West Danby gardeners have reported that they did have the disease, presumably from ticks in their own yards.

Whether we're walking in the Danby State Forest or in our own yards, we will all need to start checking ourselves, our children and our pets for ticks. For more information and photos on this topic, google the words *Ixodes dammini*, *Borrelia burgdorferi* and *Lyme disease*.

Trash Dumping

There has been a lot of trash dumped in various places in the forest, especially along lower Bald Hill Road and at the quarry on Traver Road, and there has been a lot of target shooting at signs and trees.

A huge black cherry on Bald Hill Road, probably worth hundreds of dollars in board feet, was recently shot up. Dave Brooks, the head forest ranger for Region 7, believes the culprits are Danby residents.

COMMUNITY BIOMASS ENERGY


