Laws & Resolutions on the Web Site What with the growing number of resolutions and laws, passed or in progress, added to the ledgers this year, some changes to the Town web site are coming.

Currently, resolutions appear within the text of the minutes of the meeting in which they were passed. A "resolution register" will be added to the web site, containing an index of resolutions— by number and brief description—and a link to the full text.

Similarly, existing laws are a little hard to find. They're listed—by number on the Town Board page, below the minutes. A table of titles and summaries will be added. On the other hand, it's fairly easy to review proposed laws, prior to the Public Hearing. The "notices" section contains a notice of the Hearing and a link to the proposed text.

Town of Danby Web Site

The Town of Danby has a web site, [town.danby.ny.us]. If you have a question about the Town, it's a great place to start looking for answers. If your answer isn't on the site, you will find lots of contact information to continue your search.

Town Clerk's Desktop

Part of the Town Clerk's job is to assure that all the required steps, from a preliminary public hearing through proper filing with the NY Secretary of State, are made for the law to be legally adopted.

According to NYS Town Law, public hearings must be held prior to the adoption of any local law or ordinance—or a substantive change to a local law or ordinance. As I wrote in the May installment of *From the Town Clerk's Desk*, public hearings are the way for

citizens to get involved in vital quality of life issues in their community. They are a prime opportunity to observe and participate in community action. Such hearings are meant to be a public forum for expressions of support or opposition to a particular action and help assure local government's accountability to its constituents.

Public input is a vital part of Town business. While citizens are encouraged to at-

tend any—and all—meetings of the Danby Town or Planning Boards, special "invitations" to public hearings are made through legal notices in the Ithaca Journal, and notices posted on the Town web site and bulletin boards in the Town Hall.

Upcoming Hearings for changes in Local Laws. The Town Board meeting on August 9 will be preceded by a Public Hearing on a proposal to make the Highway Superintendent an appointed position rather than an elected one. See the article by Dan Klein about this proposal and the Town Observer column. Depending on the Danby residents' input, this proposal may be presented for a public vote [general referendum] during the November election.

Other public hearings coming up include one for additions to the Road Excavation/Construction Law (including permits and fees required for different levels of construction) in September and Road Preservation Laws (additional measures to safeguard our rural country roads) in the Fall. The Town Budget process will also involve hearings and open meetings.

At a Public Hearing, comments may be made in person or in writing. Correspondence, ahead of a public hearing, is welcome and can be sent by Email to [townclerk@town.danby.ny.us] or by regular mail to Danby Town Clerk, 1830 Danby Road, Ithaca NY 14850. We look forward to hearing from you!

If you receive this publication, you are almost certainly covered by a volunteer fire and rescue organization, be it Danby or West Danby, Newfield or Candor. We all depend on volunteers—people with regular jobs and lifestyles who have joined and been trained as firefighters or emergency medical responders. We have printers, scientists, lawyers, students, dishwashers, and bartenders in the Danby Fire Company, and more volunteers

are always needed!

Danby's volunteer firefighters and emergency medical responders join for all kinds of reasons: they want to serve their neighbors, pay it forward after their own 911 emergencies, meet great people, and gain invaluable training and experiences. Maybe one or two just want a good excuse to grow a mustache!

What exactly will you do as a volunteer? Everyone knows the fire department puts out fires, but we also respond to motor vehicle accidents (MVAs), carbon monoxide alarms, wires and trees down, medical emergencies, and other potentially life-threatening events.

What you'll do depends partly on what you want to do. There are several categories of membership to choose from:

- Exterior Firefighters are trained to work on a fire scene from outside burning buildings.
- Interior Firefighters don a scuba-like breathing apparatus and fight fire in dangerous atmospheres.

GAS DRILLING TASK FORCE

During July, Task Force members prepared for our booth at Danby Fun Day, where we had information about hydrofracturing and surveys for Danby residents to fill out. We received about 30 new responses to the surveys, which will help us get an idea of what people in Danby think about this issue, and what information they are interested in receiving about it.

Five members are preparing to speak at a "scoping meeting" that will take place in Binghamton on August 12. The EPA will allow residents of Southern Tier towns to offer comments about what they want the its upcoming study on hydrofacturing to focus on.

The Town Board has recently passed a new law that regulates any road excavation, such as culverts or driveways [Details elsewhere in the Danby Area News] and is working on a road preservation law that will help us prevent or mitigate damage to local roads by large industrial trucks. While the laws apply to all industrial activity, the Department of Environmental Conservation has recommended that towns gete these laws in place before large scale gas drilling begins.

Two Town Board members are attending meetings of the Tompkins County Council of Governments, helping to coordinate laws and ordinances with other towns, and sharing our knowledge and experiences.

The New York State legislature still has to vote on several gas drilling moratorium bills in the Senate and Assembly. In addition, several proposed laws haven't even been reviewed by the relevant committees; they will probably be discussed in the Fall. The two moratorium bills differ in time frame: one would establish a one-year moratorium on high-volume, horizontal hydrofracturing, while the other that would establish a moratorium until after the upcoming EPA study has concluded. Several local legislators are following these developments at the state level but, right now in Albany, the main concern is passing the budget, which is about four months late.

We hope to have some new speakers come to Danby. Todd Miller has been studying Danby's aquifers for the past year; we'ed like him to talk about the results of his work. Water contamination as a result of "fracking" is a big concern, and it would help us all if we had a better understanding of where our water supply comes from, and how we can protect it. Danby has an unusual divide in our water flows: creeks in the northern part of town to the north into Cayuga Lake, and those in the southern part flow south into the Susquehanna River.

At the Federal level, there are still efforts restore controls on the natural gas industry, in order to protect our drinking water, among other things. The industry was exempted from these safeguards in 2005, and Maurice Hinchey has led an effort to have them conform to the same regulations that other industries abide by. Michael Arcuri also has proposed legislation in Congress, and we will follow these bills in the Fall.

We will also be writing letters in support of various bills, and we'll have letter writing workshops at the end of the month, when Danby residents can come in and get help (addresses, names, committee titles, and sample letters) to write to their representatives in both state and federal government.

The next meetings of the Danby Gas Drilling Task Force will be in Town Hall at 7pm on August 11 and 25. These meetings are open to the public; we encourage people concerned about gas drilling, whether they own leased land or not, to come and find out what we're doing.

- Emergency Medical Technicians (EMTs) stabilize sick and injured people for hospital transport.
- Support Staff help with events, fundraising, grantwriting, or whatever other work they are interested in, but do not respond to emergency calls.

So, there is really something for everyone.

What's involved? If you are at least sixteen years old, stop by the brand new Danby fire station any Monday night around 7pm and talk to us. Your application will be voted on at the next business meeting, the second Monday of every month (this month: August 9). Once the Company and the Fire District's commissioners have approved the application, you'll need a physical (paid for by the Company) and a clean arson check. Then we can get you signed up for County training.

If you're looking for lifelong friends, life-altering experiences, and the chance to save lives, join your volunteer fire company. The Firefighter 1 course that certifies Interior Firefighters runs in the fall and the spring, so apply in August if you want to get into the fall class! \$

SUPERVISOR'S UPDATE

This month, I'll update on some issues and pass along info about new projects that you might be interested in.

During the winter, I let you know how I was doing with my wood project, to address my own fuel-oil consumption. As a part of the Town's efforts to reduce our energy consumption, we have received grants to install energy efficient lighting and programable thermostats in Town Hall, along with insulation and a wood-fired furnace for our Highway barns.

In the course of these endeavors, we became involved with the County and Cooperative Extension's efforts to help us confront energy needs and alternatives to fossil fuel consumption. The following is an invitation for those of you who might like to replicate some of the efforts we are pursuing, to your own benefit.

Cooperative Extension and the Ithaca Neighborhood Housing Service have put together and exciting pilot project for homes in Danby that are heated with liquid propane gas (LPG) or oil. Homeowners who participate in this pilot project will likely cut their heating bills in half. The project's approach is to combine energyefficiency work with the installation of a pellet stove, and then guarantee the supply of wood pellets at a reduced price. The plan is to implement this approach in 24 homes throughout the County before November of this year, and then to monitor fuel use and overall costs of heating in those homes over the next two years.

All the energy efficiency and wood stove installation work are to be done by certified technicians and every step in the process will be under the guidance of CCE and INHS staff. Because we've been able to arrange for some small incentives and low interest financing, any homeowner who participates in the pilot project will experience a net positive cash flow: the savings on heating bills should be more than the total of any loan payments.

The homes in this pilot project will be representative of all major house types in the county's rural areas, and the results of this pilot are expected to demonstrate the feasibility of this approach for all of the different house types in the county.

The overall goal is to gather data and share it with homeowners and policy makers, and to arrange for the sharing of the experiences of the pilot's participants with other homeowners throughout the County. In the end, it will help others take advantage of this approach to reducing heating costs.

There are about 8,000 houses, overall, in the County that heat with heating oil or LPG. If all of them used this this approach, about \$7.5 million would be saved annually...and we would switch from buying fuels that are not renewable to a fuel that can be produced right here in Tompkins County!

Hopefully, by the time you read this, the contracts for repairs to and painting of the outside of Town Hall and painting will have been awarded. We have been saving for this project for several years and are ready to confront the four faces of the tower and cupola, along with the East face of the building.

We are still working on Broadband (please call for updates), new road classification and permitting. The Town Board held its first public hearing and passed new legislation for our roads this month. We will be following up with more public hearings in the months to come.

Budget will be our next big project; like all municipalities, we will be very challenged this year. I am letting everyone know that we are starting to address these issues at Town Board meetings, and I encourage all residents to stay informed. Your input is encouraged to guide the Board when it faces difficult choices.

HIGHWAY SUPERINTENDENT: ELECTED OR APPOINTED? Submitted by Dan Klein, Councilperson

Danby may have a choice to make this Fall, concerning how one of our public servants are chosen. Currently, the Danby Highway Superintendent is an elected position. On Monday, August 9, 6:30pm, in the Danby Town Hall, there will be a Public Hearing to begin the process of deciding whether we want to change this position from elected to appointed. The final decision would be up to the voters of Danby this November.

The reasoning behind switching this position from elected to appointed is that it is not a political position. It is a technical position which requires the best person for the job. Currently, the only people eligible for this position are adult residents of Danby (and that is the only requirement!). No one currently working for the Danby Highway Department is eligible to run for Highway Superintendent...because they are not Danby residents.

On the other hand, Danby residents may want to keep the current system so that they have more direct control of who their public servants are. Keeping this position as elected rather than appointed could provide more checks and balances in government.

If you want to have your opinion on the record, either come to the Public Hearing or submit something in writing ahead of time. If it does go to a referendum in November, you will hear more about it before then. A short extract from Joel Gagnon's Broader View articles

From the June Town Board Meeting

The Town Clerk was asked to continue being an agent for DECALS (the Department of Environmental Conservation Automated Licensing Service). The new Danby town Clerk, Pamela Goddard, is already authorized by the state, and will continue the sale of hunting and fishing licenses.

From the July Town Board Meeting

Changing from an elected to an appointed Danby Highway Superintendent has been discussed for years, but never formally proposed. The idea moved to center stage in July. So, why now?

The problem at hand is the requirement that the Highway Superintendent, like all other elected officials, be a Town resident in order to run for office. In the past, the highway crew has consisted mostly of Town residents... but currently, two new hires are the only Town folk.

It is hard to propose this change without it appearing to be an effort oust the current holder of the office, but the current holder of the office is looking to retire and, with no obvious successor within the department, Councilperson Dan Klein took the initiative to suggest that now is a good time to bring the matter before the public. He further argued that, since the job is more technical than political, it would make sense to broaden the pool of applicants beyond the Town's borders.

If there is public support for the change at the hearing, the Board could pass a local law making the change, but still subject to voter approval. The question would then appear on the November ballot for Danby voters to make the ultimate decision.

Judging from discussion, support is very tentative. Carl Seamon, the current Highway Superintendent, initially was in favor but, after talking with colleagues in other Towns, has now changed his position. Other Superitendents cited a possible loss of authority.

As it is, the Superintendent has considerable latitude in how the department is run, subject to Town Board agreement on capital projects. Because the Town Board controls the money, even an elected Highway Superintendent can't get too far away from the Board's wishes.

Some questioned whether the position might become more, rather than less, political if it were appointed, with the person serving at the whim of the Board or Supervisor. In response, the Town's attorney reported

that removal from the position would be subject to civil service rules and would have to be for cause.

The matter boils down to whether the residents of the Town want the Highway Superintendent answerable to them directly—at the polls—or indirectly by way of the Town Board. Another question is whether the loss of direct control by the public is offset by the advantage of having a larger pool of qualified job candidates.

At the public hearing on the proposed Road Construction Law, the only question was whether a permit would be required every time someone wanted to put up a mail box. The answer was that the proposed law contained a specific exemption for mailboxes and similar structures. The Board proceeded to to approve the new law by a unanimous vote of those present.

The way the law is structured, excavation for culverts, cross pipes, driveways, and the like will require a permit. The permit application will require enough information to allow the Town to determine the liklihood of significant impact to the road and, if an impact is

A fee schedule has yet to be passed.

More road laws are on the way to address the impact of road use by heavy vehicles. That is proceeding more slowly because, to avoid duplicate efforts, the Board is waiting to see what that role the County will play.

The Town Board spent considerable time considering what the Planning Board should focus on. Housing, Energy, and Zoning came up repeatedly; the TB chose to ask the PB to address the hamlet zoning issue in a way that takes into account future energy costs, development options, and the need for housing upgrades. That will involve revisiting the Hamlet Plan and the Comprehensive Plan to get everything to relate appropriately.

Since the first Monday in September is Labor Day, the Board decided to hold its September Agenda Meeting on September 13 and its Regular Meeting on September 20. The September 20 meeting will be in the West Danby Fire Hall, if the building is available, to make it easier for West Danby residents to attend.

CONSERVATION ADVISORY COUNCIL CREATED

During its June meeting, the Danby Town Board created a Conservation Advisory Council (CAC). The role of the CAC incorporates features requested in a series of well-attended town meetings in 2004, and is based on the NYS enabling legislation for CACs: to inventory and map "open areas" and assess their ecologically suitable use.

The breadth of the charge given to the CAC goes well beyond the minimum provided for in the State legis-

lation. The Board has tasked the CAC with identifying the lands most desired for retention in an undeveloped state and given it the tools to work with landowners to protect the

land—using entirely voluntary measures. These include the use of conservation easements (the gift or purchase of the rights to develop the land) as well as the actual acquisition-again by gift or purchase-of actual parcels for conservation purposes.

Land protected by easements is not necessarily open to the public, unless desired by the land owner; Townowned conservation land would be. In addition, for Town-owned land, the CAC will develop management plans to enhance and preserve those features that are

judged to be most valuable. The Town Board will oversee all activities of the CAC and Town Board approval of proposed acquisitions and management plans is always required. Public comment and assistance will be a part of all aspects of the CAC's work.



Now that the resolution has passed, the next step is to appoint members to the CAC. Five to seven Danby residents with a demonstrated interest in preserving land are required. If possible, these will include a farmer, someone with a history of working for the protection of natural resources, one or two Town Board members, a large landowner, and someone 16 or 17 years old at the time of appointment. \$

BOARD SEEKS CAC MEMBERS

In June, the Town Board established a Conservation Advisory Council in Danby. The purpose of this group is to "...advise in the development, management, and protection of the Town's natural resources." This can take many different forms, including conducting research, coordinating other organizations with similar purposes, educating residents and legislators on conservation opportunities, and preparing management plans for municipally-owned land.

The Town Board is seeking members for this new group. Potential members must be Danby residents and have a

> demonstrated interest in preserving land in Danby. We are particularly interested in appointing people involved in agriculture, large landowners, and people known to advocate for natural resource protection. There is also an optional youth slot for someone 16 or 17 years old at the time of appointment.

TAMARACK LEAN-TO REBUILD Submitted by Ronda Roaring

More than thirty people—from as far away as Buffalo, Rochester, and Syracuse-came to Danby recently, to help the Cayuga Trails Club (CTC) construct a new Tamarack Lean-to in the Danby State Forest. Construction was funded in part by an award of \$2,213 from Eastern Mountain Sports (EMS) on Meadow Street in Ithaca.

The Ithaca EMS store raffled off a Perception kayak. "The contribution from the EMS kayak raffle helped a great deal and, when combined with a challenge cost share agreement with the National Park Service, and logs and lumber donated by DEC, all our costs were covered," said CTC vice-president Gary Mallow. Logs and lumber were delivered by the DEC. Many volunteers stayed overnight at Camp Badger on Fisher Settlement Road, which provided housing and meals at no cost.

The lean-to was built of pressure-treated logs, galvanized bolts, and roofing, and completed on July 1, 2010. Mallow hopes it will last as long as the old one: almost 45 years. \$
