HAVING A STROKE? Call 9-1-1 Immediately!

E.A.S.T. is an easy way to remember the sudden signs of stroke. When you can spot the signs, you'll know that you need to call 9-1-1 for help right away. F.A.S.T. is:

- F: Face Drooping Does one side of the face droop or is it numb? Ask the person to smile. Is the person's smile uneven?
- A: Arm Weakness Is one arm weak or numb? Ask the person to raise both arms. Does one arm drift downward?
- S: Speech Difficulty Is speech slurred? Is the person unable to speak or hard to understand? Ask the person to repeat a simple sentence, like "The sky is blue." Is the sentence repeated correctly?
- T: Time to call 9-1-1 If someone shows any of these symptoms, even if the symptoms go away, call 9-1-

1 and get the person to the hospital immediately. Check the time so you'll know when the first symptoms appeared.

Stroke treatment has come along way in recent years, but early recognition is key. Remember F.A.S.T.!

TOWN CLERK'S DESKTOP

I'm pleased to write this month's Clerk's article on a rare Saturday morning in January. The sun is shining brightly through the windows of the Town Clerk's office while I work on tax collection and the recent meeting minutes. I have no illusion that the harsh cold of winter is over, but blue skies and sunshine sure do help us all get through the season.

Tax collection started with a crawl (perhaps due to January's cold and blowing snow) but gained pace as



the month progressed. After February 2, we are no longer able to accept partial payments on tax bills, and a penalty of 1 percent per month is added to outstanding tax bills. For those who made an installment payment in January, remember that your second installment is paid to Tompkins County Division of Finance (125 East Court Street, Ithaca) and are due by July 1, 2015.

Sometimes, the business of local government (paid for by your tax dollars) can seem mysterious. The best way to learn about your Town government is to sim-

ply be involved. Even early in the year, there is much to be involved in, from making comments about the situation that took place around New Year on Hornbrook Road, to learning about a the potential business enterprises on Gunderman Road in the old Angelheart "Planned Development" zone.

Many of the avenues of public participation begin at the Town of Danby web site at [townofdanbyny.org]. Some news and pieces of important information are up front on the web site home page. Others take a bit of looking around. The new web site is continually being added to and improved, so please share your ideas with us. Here are a few specific ways to stay informed and involved with local government:

Contact Board members. All Town Board members and chairs of other official Boards and Committees have Email addresses dedicated to that purpose. These addresses were listed in the January Danby Area News. In general, an official's address begins with their first initial and last name and ends with "townofdanbyny.org. For instance, I can be reached at [pgoddard@townofdanbyny.org] and my deputy, Susan McLellan, at [smclellan@townofdanbyny.org].

Attend meetings. Meeting agendas are available through the Town Clerk's office and should be posted in the calendar section of the Town web site. Follow the link for "calendars" and click on the meeting in question. If you don't find what you need, contact the Board chair or the Town Clerk directly and we can forward what you need.

If you're unable to make it to meetings, read the minutes. For example, Town Board minutes area available by following the links to "Boards and Committees," then to "Town Board," and then to "documents." A similar path will be followed for the Planning Board, Board of Zoning Appeals, and Conservation Advisory Council. If you don't find what you need directly on the web site (it sometimes takes a while for documents to get added there), contact the Town Clerk's office directly at 607.277.4788. We can send you most anything you need.

From February through mid-May, the Town Clerk's office is open 10am-5pmon Monday, Tuesday, Wednesday, and Friday, and 10am-Noon on Saturdays. As always, we are closed on Sundays and Thursdays.

DRINKING WATER SUPPLY SURVEY Submitted by Steve Winkley, Rural Water Association

In order to help protect the availability and quality of our drinking water resources, the Town of Danby is working with the New York Rural Water Association (NYRWA) on a source water protection plan. The purpose of such a plan is to reduce or eliminate the potential risks to drinking water supplies. An initial step in the development of this plan is to collect information on the nature of water supply issues here in Danby.

As part of the effort to better understand water supply resources in Danby, NYRWA has created an online drinking water supply survey at [surveymonkey.com/s/DMCRWC6]. In addition, there is a link to this survey on the Town's web site [townofdanbyny.org]. Your help in our effort to protect the drinking water of Danby would be greatly appreciated. Our hope is that you can spend a few minutes and complete the water supply survey. Responses to this survey will be confidentially sent to NYRWA, a non-profit organization of small communities and rural water/wastewater systems in New York State. They hope to collect the responses to this survey by February 28, 2015. Thank you very much for your assistance.

West Danby Water District Update

Extreme cold postponed work for two weeks but Moody & Associates began the work of repairing

the leaking seal on the District's water pump on Monday, January 19. The repair process is taking advantage of the three days worth of water stored in new tank; while the repair work is done, water will be supplied from the tank.

There was a scare on Friday the 16th, when a line leak caused consumption to rise enough to reduce the three-day storage capacity. That leak was fixed and no others have showed up during the pump's down time.

As this article is being written, mid-repair, there's been a hiccup in the process. The well shaft had a smaller diameter at the bottom than at the top, and the new pump wouldn't fit. Tod Sukontarak and Carl Sea-

mon drove to Auburn to pick up a temporary pump that could fit in the shaft, and it will be down in the well while all the permanent parts are cleaned and inspected by Moody. Once that is done, Moody can supply any needed parts and then re-install everything back to normal...or better than normal.

As reported previously, the repair of the seal will be funded through the Infrastructure Grant; they allowed the Water District to extend the grant closing date for a few weeks.

SUPERVISOR'S UPDATE

Some important events you should be aware of:

The Town Board plans to set a date (perhaps February 9) for a public hearing to consider zoning changes that would allow a variety of new uses at the former Angelheart Designs/Flax barn on Gunderman Road. The present owner, JLF Holdings/David Hall, envisions use of the building and its addition for several kitchens to process local farm products, a community kitchen for short term lease by caterers and farmers, a business incubator, offices, clinics, auctions, and his own business, National Book Auctions.

The Planning Board has studied the proposal and has recommended its approval with conditions, including water testing to see if there is influence on neighboring wells once water usage reaches a certain point, limits on the number of employees, and limits on truck traffic.

I lead off this month's area news with the above hearing announcement because you need to be aware that the Town has several big ticket items before it. The Gunderman Road Project is first on our agenda.

It is important for a number of reasons, not only for the ones I outline here. I believe the Town has some responsibility in 'growing' local farm-to-table ventures and businesses. It is exciting to see some of these grassroots enterprises take route in our community.

On the other hand, for the residents who live in proximity to the property covered by this proposal and who have historical water problems, sufficient controls must be put in place.

All of this takes longer than participants might desire but, I believe and as past experience has indicated, information and a public process are important. I look forward to hearing your input on this Project.

Another important item on the table for your attention and review is the culmination of the work we have been doing over the past few years on protecting the water in the town of Danby. For over a decade, Danby has been investigating its Aquifers and other water resources. Since 1989, the Town's Comprehensive Planning has stressed the vital importance of water.

A group of residents is working with Steven Winkley of the New York Rural Water Association on a draftgroundwater resource protection law, for public information and comment. That law will be part of our future Danby Source Water Protection Plan. Right now, though, please help us. Just take a few minutes and fill out our Online Drinking Water Supply Survey by February 28. The survey is confidential. The survey can be found at [surveymonkey.com/s/DMCRWC6].

In closing, on a sad note, regarding the ongoing tragedy of a family from Hornbook Road. The Town is still involved in working to understand this incident. The Town Board followed up my request to the Sheriff's office for an "after-action" report with a resolution also requesting that report and the formation of an independent committee to review the Sheriff's report.

Conservation Advisory Council, 2014 Report

Conservation Easement Program

Looking back on our efforts this past year, the conservation easement program completely dominated our activity. When 2013 ended, we were in the final stages of completing our first easement, with Art and Donna Hanson, on a 25-acre parcel on Sandbank Road. This is located in a part of town on the border with Ithaca and consequently subject to fairly intense development pressure. It is also some of the best agricultural land in the town. To have the Hansons willing to cede their development rights was exceptionally valuable to the town. The property has since been sold to the adjacent landowner, who is in the initial stages of planting an orchard and creating a cidery. That easement finally closed in July, culminating in a formal signing ceremony consistent with its import to the town. With this being our first easement, there were a lot of procedures to work out. The town clerk and code enforcement offices were both supportive and of great assistance, and the help of the town's attorney Guy Krogh invaluable.

Two other easements occupied us rather well for the balance of the time, and served as rather intense "learning by doing" experiences for council members Jake Brenner and Matt Ulinski. Matt was chief negotiator for the easement offered by Erick Palmer and DeAnna DeMark for a 14.3-acre parcel at the corner of Marsh and Deputron Hollow roads, and Jake for an adjoining 42-acre parcel on the opposite side of Deputron Hollow Road that includes a considerable part of the upper reach of the gorge. This second parcel was offered by Ted Melchen. Both of these easements were influenced by and handled in conjunction with a proposal to extend the year-round maintenance portion of Marsh Road. The willingness of these property owners to place restrictive easements on their properties was somewhat contingent on the town's willingness to reclassify the road, and vice-versa, complicating negotiations. The Deputron Hollow area is still mostly rural and scenic, with the hollow itself recognized as a unique natural area.

Protecting more of it would be of considerable value to the town; we sought to make the easement donation a positive experience for the donors and hope we have succeeded. As of this writing, approvals are in place by all parties but a final closing is still to be effected.

The primary thrust of Danby's conservation easement effort is to reduce housing sprawl while restricting

property uses minimally just to reduce the potential for abuse and degradation of the land resource. We thus spent a considerable and very worthwhile time on the issue of what constitutes a seasonal use cabin in the course of crafting the Melchen easement. We sought to ensure that what all now agree will be a seasonal use cabin does not over time and under a variety of owners evolve into a more permanent dwelling, thereby adding housing where none had been intended to go. Erick and DeAnna were very helpful in getting us to a definition that all could agree was highly unlikely to allow a cabin to morph into a house, and the result will likely assist the town in crafting relevant rules and regulations that can apply to seasonal cabins elsewhere in town, particularly when they are located on seasonal use roads.

Management Plans for Town-owned Properties

We resumed work on the town-owned property located on Deputron Hollow road, seeking clarity regarding its location and size. The tax map had the town owning 16 acres on the north side of the road and nothing on the south side. The deed indicated 10 acres on the north side and 14 acres on the south side. Since the chain of title for the south parcel is clouded, we focused on the north side. That property was surveyed and is now marked appropriately. We also concluded that given the relatively young age of the regrowth on that property, our "plan" for it should be to leave it alone for a while. We have yet to run that by the public, a necessary part of the development of a plan.

Late in the year, it came to our attention that the town owns another parcel that we were not aware of, located in West Danby. This is the property that the water district tank and well are located on, adjacent to and uphill of the Fire District's land on which the West Danby Fire Station is located (the fire District parcel was purchased from the town for the purpose of locating the fire station). We have yet to investigate this property, but as a mostly wooded site with quality mature trees, it is a substantial asset worthy of careful consideration and management. It will be a focus in 2015.

Looking Ahead

With solid experience in place in executing conservation easements, we anticipate that we can be more proactive in approaching landowners to encourage donations of development rights. Thanks to CAC member Jake Brenner, we now have an open space inventory, maps, and methods we can use to prioritize our efforts. We are excited by the prospect of expanding our easement program and expect that to be a major focus of our work this coming year.

BROADBAND IN DANBY UPDATE

More than six months have gone by since my last *Broadband Update* in the Danby News and, this time, I have some good news to report.



Clarity Connect hasn't been idle all these months. Although the grant funding from New York State was not coming in, Clarity began installing towers and equipment, either where the locality was contributing to the project, or where Clarity could scare up capital to

work on its own. Although none of this activity was in Danby, Clarity was able to begin providing service to those Danby residents whose homes had a view of towers to the West and Southwest.

Several West-facing residents have given me positive reviews of the service they're getting, but there have been some bumps as Clarity learned how best to utilize the new equipment. According to Clarity, they've learned enough from the "teething pains"—and established good communications with the equipment manufacturer—to avoid similar problems in the future.

In August, my more traditional high-speed service, which is provided by Clarity using Verizon's infrastructure, was down for a week. In an effort to work around Verizon's phone line problems, Clarity was kind enough to evaluate a temporary wireless option for me. In Northwest Danby, we could "see" a tower but, even with an antenna mounted on a tall mast, the trees and leaves were too thick to allow useful service. In Central Danby, overlooking West Danby, excellent service could have easily been obtained from a tower in Newfield. Although I was upset about the outage, this effort by Clarity was more effective than what I've come to expect from the "big boys" of the internet industry.

Since then, the key news item is that it appears that the contract with NY State was completed. This opens the pipeline for grant funding. The first reimbursements (NY requires Clarity to spend first!) are not expected before March 4, and then Clarity can resume large-scale infrastructure work.

The small-scale work, however, continues. Clarity has installed some equipment on the existing Countyowned tower in southern Danby. This allows service to be provided to additional residences, those with a direct line-of-sight to the tower. I've heard from a resident on upper Bald Hill Road, who expects service to be installed in late January.

Clarity has told me that, if you've already contacted them to indicate interest in the fixed-wireless Broadband Internet service, they will notify you when your location can be served. I have an old, old coverage map that suggests that the new tower may also "see" some residents in the Curtis Road, Michigan Hollow Road, western East Miller Road, and White Hawk regions. I don't know what Clarity knows but, hey, your phone may ring.

Local residents who are less free to attend morning or early afternoon activities will find these new opportunities particularly attractive. While extending its programming in this way, Lifelong will continue to offer recreational and healthand-wellness oriented activities as well as opportunities for self-expression in the arts (painting, singing, acting, dancing), along with courses and presentations of a more traditional academic sort (Shakespeare, American History, foreign language study, "Galaxies and the History of the Universe," "Getting to Know the Microbes in Your Life," and many more).

This spring's instructors will include many who are well known to current members of Lifelong as well as several new volunteers. The Lifelong Learning catalog, which is available free of charge (online at [tclifelong. org], at the Lifelong facility (119 West Court Street), and throughout Ithaca and Tompkins County) provides biographical sketches of all instructors as well as descriptions of over 90 Spring 2015 offerings, with information about registration and fees.
