Dino has performed at many notable venues throughout the country and abroad including Blue Note, Birdland, NBC Rainbow Room, and Dizzy's at Lincoln Center.



# TOWN CLERK'S DESKTOP

As I write this, we are halfway through January's annual property tax collection period. After an uncharacteristically slow start, we're now working our way through the piles of payments that are arriving in the mail, and enjoying lots of visits with Danby neighbors who pay in person. We can fully expect to be busy the rest of January, with a blizzard of checks coming our way in the last week. After February 1, there is no longer the option to pay by installment.



Town and County property taxes are collected at the Danby Town Hall through the end of March. During February and March, taxes must be paid in full, and will have a 1 percent per month penalty added. After April 1, property taxes must be paid at the Tompkins County Finance Office. If you pay in installments, the second installment is paid to Tompkins County Finance. And yes, payment is accepted by postmark date (as stamped by the USPS).

Remember, Town Clerks are only tax collectors. We don't set your assessment or your tax rate. I know that there's little I can do to make winter and tax collection better than it is, but I can promise that the candy bowl will be filled with chocolate kissesincluding plenty of dark chocolate. Sue McLellan and I can renew or issue dog licenses, issue marriage licenses and parking permit tags, and answer questions about Town government...all at the same time.

Here's a reminder about Dog Licenses: they must be renewed annually. It pays to renew your dog's license on time. New fee rates were adopted in 2014, and licenses that are more than two months overdue are charged a late fee of \$3 per month. We have found that dog owners are much more conscientious about renewing on time since this late fee was adopted. Renewing on time reduces Town expenditures related to mailing license renewal reminders. And it might save you from having a visit by the Animal Control officer.

The annual license fee remains \$12, as it has been for altered (spay/neutered) dogs. Unaltered dogs have a license fee of \$24 per year. So, should you choose to spay/ neuter your animal the license fee is halved. Thank you to those of you who renew by mail and have thoughtfully included a self-addressed, stamped envelope for the return of your license and rabies certificate documents. It's a small thing, but this does help save costs for the Town.

In order to be as accessible as possible, the Town Clerk's office will be open 10am-5pm Monday, Tuesday, Wednesday, and Friday, and 10am-Noon on Saturdays. As always, we are closed on Sundays and Thursdays.

# WEST DANBY WATER DISTRICT UPDATE Submitted by Tod Sukontarak, Water Commissioner

During the last month a Town resident has rightfully brought my attention to the fact that the West Danby Water District has not been in compliance with the NYS Open Meeting Law. The OML dictates how Town organizations are to conduct their affairs.

The biggest issues for us have been not notifying the public, either on the Town web site or in a public periodical, about meeting times or posting minutes from those meetings. With the assistance of staff at Town Hall, the Town Board, and the District's Commissioners and Operators we are working to correct our noncompliance.

We are now scheduling regular quarterly meetings of the District's Commissioners and Operators--with minutes taken--and both times and minutes will be posted on the Town web site.

Our meeting times will be announced in the Danby Area News as well.

That said, at our most recent meeting on January 16, we discussed plans for projects in the near future and longer term. We have a leaking roof on the pump house that needs to be addressed soon; longer term we need to begin thinking about replacing corroded plumbing in the pump house.

Our next quarterly meeting will be Wednesday, March 9, 7 pm, in the West Danby Fire Station. Between now and then, we will be having an interim meeting on Wednesday, February 17, 7pm, in the WD Fire Station, to discuss research accumulated about our roof leak and plumbing repair projects.

Taking care of Danby, trying to help people realize their dreams for their property use while protecting the char-



acter of our town, was everything to Sue Beeners. Her dedication to the Town, the relationships she had with residents, and the town history that she carried in her mind are legendary. Sue put great effort into the first

> Danby Comprehensive Plan, several zoning updates, Stormwater Protection legislation, Danby's Road Use and Protection Law, and the 2011 Comprehensive Plan Amendment and Local Law to *Prohibit Gas and Petroleum Mining and Related Activities* (a.k.a. Danby's Fracking Ban).

> Sue Beeners had a remarkably sharp mind and the extraordinary skill to recall details of local laws and the relationship between local ordinances and County and State regulations. And, all was done with a cheerful nature. Sue Beeners is deeply missed.

> Sue Beeners is particularly remembered for her joyful involvement with Danby Fun Day. Supporting Danby Fun Day would be a wonderful way to remember Sue. This

could be in the form of a financial donation, or by volunteering to help with the parade, silent auction, food preparation, book sale, or in any other way. Sue always saw Danby Fun Day as an important communitybuilding event. Fun Day is a way to celebrate our little town, bring people together, and support the Fire and Rescue Squads.

At Fun Day, in the warmth of July, we can remember Sue yet again.

### County Legislature Update

This month I'm going to touch on two topics that the Tompkins County Legislature has recently been involved with.

#### Minimum wage

Tompkins County passed a resolution in support of Governor Cuomo's initiative to make \$15/hour the statewide minimum wage, to be phased in over five years. There are several ways to think about this issue. I want to focus on a practical aspect of it for a moment.

There is no doubt that some people will benefit and some people will suffer from an increased minimum wage. NY State already has established a phased-in minimum wage for fast-food workers, NYS government workers, and for SUNY employees. Having a patchwork of different minimum wages based on who is your employer is not a good system in my opinion. Leveling the playing field is the best thing we can do to minimize the negative impacts, which is why a statewide minimum wage is the fairest, most practical solution to address some of the poverty issues we face.

Tompkins was the first county in the state to pass such a resolution.

#### **Body Cameras**

The Tompkins County Legislature recently allocated money for body cameras for the Sheriff's Department.

Body cameras will soon be worn by all Sheriff's personnel while engaged in law enforcement operations.

The County Legislature and the Sheriff's Department have an interesting structural relationship. The Legislature sets the budget for the Sheriff's Department but has no say in the Sheriff's policies. The Sheriff is an independently elected official. This could be a recipe for gridlock, but I would say that the Legislature and the Sheriff's Department have a pretty good working relationship.

In the case of body cameras, the Sheriff's Department is establishing all the policies regarding when, where, and how cameras will be used and the how the video will be stored and be made accessible. The legislature allocated \$46,500 for the purchase of the cameras and related equipment.

I think it's fair to say that most law enforcement supporters and most offender-rights advocates agree that body cameras are a positive development. They provide an objective record of what happens during a law enforcement operation and can verify or disprove accusations on both sides.

I first met Sue when Danby was working with the Town of Ithaca to to build the South Hill Recreational Way. I was so impressed that later, when the State changed the rules defining zoning enforcement responsibilities, Danby hired Sue to sort out our new roles and responsibilities. Finding knowledgable people to help us get a grip on where the Town needed to go fell to Sue.

Over the years she established herself as the compass for Danby planning and development. The five housing developments we worked with, the rewriting of the Comprehensive Plan, the West Danby Water District, Broadband Legislation, Solar regulation and the installation of our solar arrays at Town Hall, the grants we have written, the Aquifer Study, the building of the present-day Town Barns, the subsequent building of our Salt Barn, our new Road Use laws and Fracking Bans, working with FEMA for disaster relief from tornados, floods, and fires, and *good* stuff like Danby Fun Day...were all efforts that Sue was involved with.

Never one to shy away from contentious issues, Sue certainly had her hands full. I knew Sue for many many years, through good times and bad, and I always saw her as our guiding star, our go-to person, and our reservoir of information.

Sue was also old school. She belived in her community above all else, she was committed to its health and well being and she fought her whole life trying to nurture it. Her job was her life and its loss is our loss.

In our crazy world we do not often see people dedicated their lives to their community. Our community a better place because whenever it drifted toward contention, conflict, and challenges, Sue kept us centered.

### DANBY FIRE DISTRICT PRIMER

The Danby Fire District is a creature of NY State Law and is responsible for providing 24/7 fire and rescue services on an on-call basis as well as basic life support Emergency Medical Service (EMS) throughout the Town of Danby.

These tasks are are accomplished two fire companies more than 40 volunteers—operating nine fire and rescue vehicles based in two stations. One is located at 1780 Danby Road (NYS Rt.96B) and the second is located at 47 Sylvan Lane (off NYS Rt.34/96).

The Emergency Services, Fire and EMS, in Danby confront unique topographical challenges. Danby's topography was carved by glaciers and the Town contains two ridges running North-Northwest by South-Southeast; the ridges divide Danby into three valleys.

NYS Rt.96B runs through the central, most populous valley, NYS Rt.34/96 is the highway in the western valley, and Coddington Road lies in the eastern valley.

Danby's two population centers, the Hamlet of Danby (on NYS Rt.96B) and the Hamlet of West Danby (NYS Rt.34/96), are separated by a 5.25 mile, partially unpaved road crossing an 1800-foot high ridge. Thus, we have two fire stations and two fire companies.

In 2015, the District's Companies responded to more than 255 calls, including fires, hazards, and about 150 medical emergencies. We also answer calls for aid to neighboring departments.

The District operates several fire trucks and apparatus:

2 Engines: both built in 2013, carry the hoses, ladders, tools, and 1000 gallons of water each; these are our primary units.

2 **Tankers**: one built in 1975 and the other in 1999, each carrying water and a portable water pond. There are a few hydrants in West Danby, but none in Danby.

2 Quick Attack/Brush Trucks: one built in 1985 and the other in 1991. These are supplemental vehicles but have the capacity and tools for brush and wildland fires.

2 Emergency Medical Vehicles: One built in 1995 and the other in 2005. These serve as first responding medical units.

1 Utility Truck, built in 1989.

The Danby Fire District, as required by NYS law, has five elected Fire Commissioners. Their job is to create and vote on budgets, develop long range plans, guide the Fire Chiefs, provide for the stations, the apparatus, and upkeep, conduct official business, apply for grants, maintain books to State Standards, and oversee the policies and finances for the Fire District. They are supported in their work by a Secretary and a Treasurer.

The Commissioners are: Wayne Westmiller, Chairman; Katherine Anderson, Kevin Faehndrich, Joe Freedman, and Edward Kokkelenberg. The Secretary is Sharon Gaden and the Treasurer is Deanna Bowles. The Secretary and the Treasurer are the only paid part time employees of the District (as allowed by NYS law). Both of have also contributed many years of volunteer work to the Fire District.

The Fire District Taxes are calculated by the County, based on the Fire District's approved budget and the County's property valuation. The Town of Danby then sends out the tax bills, collects the tax payments, and transfers funds to the Fire District. In 2016, this will be about \$499,000.

As mentioned above, the District has

two separate Fire Companies. Each has a Chief (who reports to the Commissioners) and Assistant Chiefs, all of them volunteers. The 2016 officers are:

Each company's has volunteers who serve as firefighters, as EMS personnel, as Fire Police, and as support personnel; Danby has 26 and West Danby has 17.

Finally, each Fire Company has its own organization that both represents, and serves as a benevolent association for, the Company. These officers are elected by the individual Fire Companies.

### FIRE DISTRICT VOTING February 2: New \$350,000 Bond Referendum


The Fire District has issued a legal notice (included on this page) describing a Bond Referendum to be held February 2, 2016, 6-9pm. West Danby voters take note: Voting will take place only at the "uphill" fire station, 1780 Danby Road.

The Bond Resolution (that must be approved by voters) allows for the purchase of a new tanker truck, along with accessories and services, for a total of \$353,344. Of this amount, \$350,000 will be financed by the issuance of serial and/or statutory installment bonds. The remaining \$3,344 will, presumably, come from existing fund reserves. The fund reserves have been augmented by the recent, roughly 23% increase in the Fire District levy, that you saw on your tax bill in January.

The new bond will be added to the existing debt service—currently paying down bonds issued for two previous engine/pumpers and the stations—of more than \$110,000 per year, one quarter of the Fire District's budget. If the increased tax levy remains in place, the extra funds can be used to pay off the District's bonding—borrowing—more rapidly.

The need for this tanker was described in Commissioner Kokkelenberg's article in the October, 2015 issue of the *Danby News*. Future replacement of the brush trucks was described in the January, 2016 issue.

\$350,000 is a substantial purchase and a substantial debt load—about 70 percent of the District's 2016 budget—and deserves more public interest than the two-dozen-odd voters who participated in the District's election last December. Danby residents are encouraged to learn about the District's function and needs (see article on opposite page). Armed with as much information as you can get, get out and vote on February 2, 2016, 6-9pm, 1780 Danby Road!

# GETTING A PHONE IN DANBY

It's such a simple thing to make a phone call, once you have a phone and a connection to a phone company. Why then, did it take me more than a month, a dozen or more phone calls, and the assistance of the NYS Public Service Commission (PSC) to hear a dial tone via my wired landline?

And, why am I now hearing similar stories about other prospective telephone customers in Danby? Take a comfortable chair and listen to my tale.

Two years ago, Verizon kindly provided me with about 1500 feet of cable. I promised to bury it between the Verizon service access at the road and my house un-

#### Landlines vs cell phones

There are alternatives to a wired landline, but they do not always work with answering machines, faxes, alarm systems...and stop working when the power goes out. Internet telephony is particularly susceptible to outages.

There are other tradeoffs between cellphones and landlines. Your individual situation will dictate which one is best for you. der construction. Bear this in mind: they gave me the cable because they knew it could be hooked up. No?

One year ago, I contacted Verizon sales and verified that it would be a simple thing to move my old telephone number to my new house. It might take a few days but would cost nothing. Service access was confirmed.

Last November, I made *the phone call*. I asked Verizon to connect me up and to move

my number. Uh oh. "Our system doesn't show that we provide service at your new address. I'll have to make an inquiry."

Four weeks and six calls later, Verizon engineering confirms that *there is no cable* near my service access point.

I asked the friendly, but ill-informed sales rep, carefully, whether she was *sure* there was no service. I pointed out that my next call would be to the PSC, and that following up on a complaint would be time-consuming and expensive for Verizon. "No, sir, I'm sorry, but we do not have service anywhere near you."

I walked out to the road and confirmed that the Green Box right next to my wire said, "Verizon." That, in fact, the Green Boxes marching down the road all connected to my Green Box and nowhere else. That several of my neighbors have or had Verizon service. In other words, magic aside, if they had service, I could get it.

Some might say that the left hand and the right hand at Verizon are not connected. On the other hand, more than one Internet article suggests that several phone

companies are doing their best to discourage new customers from installing landlines.

I spoke with a helpful voice at the PSC. I explained (with more detail) what I've already told you. I was promised that Verizon's Executive Offices would call me.

Within a day or two, an Executive called me. After a another week, I received an apology and confirmation that yes, indeed, there is service for me. Even the local head of Engineering called me. Verizon rushed a technician out to make the hookup. For free. Free to me, anyway.

Bottom line: if you hear of someone who has been told that landline service isn't available, suggest three things: (1) remain calm, (2) do a common-sense exploration of your neighborhood, looking for other telephone customers, and (3) call the NYS Public Service Commission. Without the PSC, you're running into a brick wall.
