Submission Guidelines: Before submitting an item for the Danby News, please have a look at the Submission Guidelines. You can request them by Email from the editor at [danbynews@tedcrane.com] or find them at [danbyny.org/DanbyNews]. If you're thinking of sending something for publication in the Danby News, there's two documents to read: the *Guidelines* and the *Submission Guidelines* at the same web location.

You'll learn what is, and isn't acceptable material for publication. If it's acceptable, we'll make an effort to include it; *generally, we print everything we receive*! You'll find hints about how to prepare a submission. Following these guidelines makes the editing and layout easier.

A terse version of these guidelines is in the left-hand column of this page.

## WHAT REQUIRES A BUILDING PERMIT? Submitted by Steven Cortright, Code Officer

T HAS BEEN MY EXPERIENCE that there is some confusion over what requires a building permit. So, here is a non-all-inclusive list that I have come up with.

Building Permits are required for the construction of:

- Single family homes, duplexes, apartment houses, townhouses, additions or alterations to any of these types of structures and conversion of a single-family home into a duplex or apartment house or a apartment house or duplex back to a single family home.
- Decks, pools, garages, sheds greater than 144 sq.ft. in size either built on site or pre-built delivered to your site, barns that are not solely for agricultural use, solid fuel burning heating appliances, chimney or flue in any dwelling unit and all permanently installed heating and cooling appliances, residential and commercial.
- All solar or geothermal installations.
- All commercial projects, all fire detection systems, all fire suppression systems, all change of use or occupancy classification and the demolition of any structure.

Building permit applications and the various fees for building permits can be found at [townofdanby.org] under the Code Enforcement link.

And of course, along with building permits comes construction inspections as required by section 108.5 of the New York State Uniform Building and Fire Code.

108.5 Construction Inspections. Any person or entity performing work for which a Building Permit has been issued shall keep work accessible and exposed until the work has been inspected and accepted by the Authority Having Jurisdiction, or its authorized agent, at each element of the construction process that is applicable to the work and specified in the stricter of the Authority Having Jurisdiction's Code Enforcement Program or a Part 1203-Compliant Code Enforcement Program.

Next month, I will provide a list of what does not require a building permit.

# FOOD SCRAP CONSULTANT WANTED

ONE OF DANBY'S HIDDEN TREASURES: every Saturday morning, 9am-Noon, behind Danby's Town Hall, a steady stream of private vehicles deliver household food scraps for processing by the County's Recycling and Materials Management department. If you don't compost, or have food scraps that aren't appropriate for your compost pile, the Saturday Drop Spot is a great way to reduce your trash!

The TC R&MM folks are looking for a new "consultant" to staff the Drop Spot. It's a three-hour, once a week event, and it pays a flat rate of \$70 per event.

What's involved? The consultant is responsible for the safe flow of vehicles and pedestrians, provides outreach materials and information regarding food scrap recycling, and, as a representative of Tompkins County, must work in a professional manner. In addition, the consultant inspects loads for the presence of unacceptable materials, ensures sufficient capacity is provided for collection, maintains the collection bins, and stocks other supplies.

A high school diploma is required and the consultant must be 18 or older and in good physical condition to handle the demands of the scope of work. For more information, contact Barbara Eckstrom, [beckstrom@tompkins-co.org].

## SUPERVISOR'S UPDATE

As I WRITE THIS ON FEBRUARY 15, we just experienced what may prove to be the coldest night of the winter, hitting minus 9 at my house. Cold, but still warmer than we historically see as our coldest wintertime temperatures, which are in the range of minus 10 to minus 20. Average temps are rising, and along with them more extreme weather events. Those events are among the greatest hazards we face in this part of the world, shielded as we are from coastal storms and earthquakes. There is a county-wide process of hazard mitigation planning, reviewed and updated every 10 years. Danby will be participating in the upcoming update, with Steve Cortright, our Code Officer, as our delegate. Hazard mitigation and emergency response are connected, and Steve brings years of experience with the fire department to this effort.

There is much more that is happening that is planningrelated. The Town Board recently passed a set of design guidelines for site plan review of commercial enterprises. These were put forth by the Planning Board, greatly facilitated by the work of the Town Planner, Jason Haremza. The Town Board also made the initial appointments to the new Planning Group, which will have held its first meeting by the time you read this. All are welcome to participate in that group; minutes will be posted on the Town website to keep you abreast of its work, and I will report highlights here as well to help pique your interest. They are charged with nothing less than helping to reposition the Town for the future!

We are working on enabling an extension of the South Hill Recreation Way. It would continue through parts of the Towns of Ithaca, Dryden, Caroline, and Danby along the old railroad bed that aligns in Danby with the Caroline-Danby boundary northeast of Coddington Road. NYSEG, which owns the 66-foot wide strip of land, has offered us a limited license to use its property, but the terms are not very favorable to the Town (NYSEG can revoke the license with 120 days' notice). Further action awaits efforts to negotiate a better deal.

A recommendation from the Conservation Advisory Council to do a salvage harvest of Ash trees on Town property in West Danby that contains the Water District infrastructure has generated a lively discussion. The Town Board asked the CAC to catalogue the environmental impacts of the options to help the decisionmaking process. As you may know, the Emerald Ash Borer has now been found in the county. Once infested, Ash trees die within a few years. Even before completely dead, the wood is ruined for lumber. Should we just let the trees die and decay naturally? Should we try to save some of them by treating them chemically in the hope that more natural controls will be developed in the future? If so, how can we do the treatment to minimize the risk to non-target organisms and the groundwater for the Water District? What are the best practices to minimize the inevitable mess from logging, and are they a reasonable cost to the environment? All this and more is being looked into and will inform the Town Board's decisions. Feel free to add your own thoughts.

A hemp growing and limited processing facility on Howland Road is of great concern to its neighbors and has taken a lot of time and effort on the part of the Town to wrestle with. Agriculture is a commercial activity, and the Town has generally been very supportive of agriculture historically. Not as welcome, though, is the large-scale "factory farming" represented by CAFOs (confined animal feeding operations) and similar highimpact operations that look more like heavy industry than traditional farming. This hemp operation dries hemp for several growers, which involves transporting loads of material and running dryers 24/7 for months at a time, with attendant traffic, noise, and odors. We are exploring options to better protect the neighborhood while not wanting to completely foreclose the growing of a promising new crop.

Expanding definitions of what is considered an agricultural activity by the NYS Department of Agriculture and Markets is generating some pushback here in Danby for the simple reason that agricultural enterprises within a state Agricultural District can operate without zoning limitations (i.e., ag district regulations supersede zoning). To reduce these exemptions to our land use controls, we have altered our stance toward the agricultural districts. The Planning Board has recommended to the County Agriculture and Farmland Protection Board that 162 properties in Ag District 1 (mostly east of 96B) be removed. We only get to recommend removals once every eight years; this is the year for District 1. The properties recommended for

# TAXES ARE HISTORY

THOUGH WE STILL HAVE INCOME TAXES to look forward to, our property taxes are history—for this year. But taxation records from years ago give us an interesting look into some of our town history.

Today the Town Clerk is the tax collector in Danby. In 1900, James O. Miller was the tax collector. I know this from an announcement found in the vault. It is titled, *\*Tax Collector's Notice\**, and goes on to say:

The taxable inhabitants of the town of Danby, Tompkins Co., NY, are hereby notified, that the undersigned tax collector has received the warrant for the collection of taxes for the present year, and that said tax collector will attend from nine o'clock in the forenoon until four o'clock in the afternoon, at the following named places in said town on the following named days and dates:

At the store in Danby of H S. Beadsley, Monday, Jan. 15 and Wednesday, Jan. 31; At C.H. Ostrander's store, Tuesday, Jan. 23 and Tuesday, Feb. 6; At the store in West Danby of Fairbrother & Snyder, Sat., Jan. 20 and Monday, Feb. 5; At A.S. Miller's house on the Coddington Road, Sat., Jan. 27; At the school house in South Danby, Sat., Feb. 3. Taxes will be received at one per cent for 30 days from date; after that five per cent will be charged.

It is signed: James O. Miller, Collector. Dated January 8th, 1900.

This is just one document that gives a small glimpse into Danby of 120 years ago and also raises questions that, if answered, can tell us more. Was James Miller also the Town Clerk? No record tells us. Three stores and one of Danby's schools are mentioned. What happened to them? Taxes were collected at different places spread around town. Think of getting to these places on horseback or in horse drawn vehicles. Is it easier to pay our taxes today or was it easier in 1900?

Some old tax documents—from the Town Historian's files—are on display in Town Hall. They reveal more small details of Danby from 1905 and 1916.

removal are mostly small and residential. Danby has a local law protecting the conduct of agriculture within the Town. That law does not supersede zoning. Rather, it applies within its constraints.

There have been two failed attempts to get the voters in Danby to approve the change from an elected to an appointed Highway Superintendent. We are now looking into proposing expanding the area from which candidates for the office could be drawn. The reason for this is simple. Historically, most, if not all, of the highway crew members were Town residents and constituted a pool of future leaders. That is no longer the case, with most now living outside the Town's borders. Drawing from a larger area would allow us to include them (and many others) in the pool of potential candidates. We are also looking into whether qualifications for the office could be expanded beyond the over 18 and a resident in election law.

Illuminating, Instructive, Helpful, and Fun.

THESE ARE SOME OF THE WORDS participants have used to describe the volunteer Energy Navigator program, whose fifth round of training begins in April 2020. Volunteer Energy Navigators from all over Tompkins County learn to reduce their own energy use and save money and help other community members do the same.

Some of the words I use are, "worthwhile, educational, and meaningful." It was really great to be able to help someone save on their utility bills. I volunteered for the third round of Energy Navigators and was able to help my community learn about free programs and program incentives—and to help them apply. "It was a rewarding experience."

Volunteers complete ten hands-on classes that cover a range of topics in energy efficiency, renewable energy, and heating options and transportation. They also learn about relevant incentives and financing. Following the training, volunteers commit to helping at least ten other community members reduce their energy use.

Over the last four years, more than forty Energy Navigators have supported hundreds of friends, family members, colleagues, and contacts from their faith organizations with actions that, together, will help them save thousands of dollars and reduce carbon emissions.

## COUNTY LEGISLATURE UPDATE

VERY SOON, THE COUNTY LEGISLATURE will be voting on whether or not to act as a financial guarantor for the proposed conference center. The conference center is a proposed \$30 million project that will be built and owned privately on the site of the Green Street garage in Ithaca. This is a very complex project with the County, the City, the Downtown Ithaca Alliance, the Convention and Visitors Bureau, private hotels, and a private developer all being asked to take a role.

There are many pluses and minuses to a conference center. There is little doubt that it would increase tourism, and tourism brings outside dollars into the County. However, it also brings traffic and parking issues to an already-congested downtown. The conference center would bring jobs. But most of the jobs would be low-end hotel and restaurant jobs. Do we want more of those kinds of jobs, especially given that we have the lowest unemployment rate in the state? We have a housing shortage. Where will all these wait staff and hotel workers live?

But the question before the County Legislature is only this: are we willing to use County tax money if the conference center can't pay its \$2 million annual lease?

In a study commissioned about conference centers in similar-sized cities, it was found that 7 out of 8 of these conference centers lose money.

If the County signs on to bailing out the conference center when it does not make enough profit, there are several proposals about how we would pay for that. One is to add 1 percent to the County hotel room tax. Another is to add 2 percent tax to the cost of Air BnBs in the County. The City of Ithaca is also contemplating charging a City hotel room tax of 4 percent.

If we do add these hotel taxes, it is still possible that we will not have enough money to cover the losses to a conference center in any given year. If that happens, we would either need to use property tax money, or take some money away from the arts and culture organizations that currently get a small allocation from the County hotel tax.

If we sign on to this deal, we would be committing for 30 years.

I am writing this in mid-February, and it is possible that a whole different set of proposals will have been worked out by the time it comes for a vote in March. But as it stands now, I wish the conference center good luck, but I will be voting no to have the County act as financial guarantor for this project.





# Community Council Youth Programs

This February was a blast! Danby youth have been busy this past month, learning how to carve canoes from basswood at Boynton Middle School, practicing cooking skills at the Danby Church, and exploring life after dark at the Danby Town Hall and in Dotson Park.

We were lucky to work with two very generous volunteers last month: Bill Evans & Nezha Oubella. Bill came out to the Night Visions program, equipped with the thermal imaging camera he uses while tracking bird migrations.
