She will invite us to consider what a good death might look like for each of us and share a few stories from her experiences with others at the end of their lives and how they inspired her.



THE CANDIDATES SPEAK!

ANBY VOTERS will be making some important choices during the Democratic primary for local offices in June. Unless some last-minute independent or write-in candidates appear, the contested races will only be between Democrats. They'll be decided by voting during a Primary Election: early voting (June 12-20 in the Board of Elections, 128 East Buffalo Street), absentee voting, and in-person voting on June 22, 6am-9pm, in the Danby and West Danby Fire Stations.

Democratic voters in Danby will choose from among five candidates—running for three contested "seats" in two offices—on the Primary ballot. An additional two offices are uncontested and those candidates will go directly to the November election ballot. How to sort out who is best for each position? One good way is to have them assemble in one venue and hear their statements and answers to questions submitted by voters.

The candidates for the Town's contested positions (Town

Councilperson and Town Highway Superintendent) have been invited to participate in a moderated Virtual Candidate Forum. All voters, regardless of political affiliation, are welcome to join the audience.

The Danby Community Council is pleased to be able to facilitate this informative Forum. The Virtual Forum will be moderated and run by the League of Women Voters of Tompkins County (LWVTC) via Zoom on Saturday, June 5, 3:30-5pm. It'll be divided into two periods, first for the Councilpersons, and the second for the Highway Superintendent.



W.D. WATER DISTRICT UPDATE

THERE WAS A 3" WATER MAIN LEAK on Monday, May 10. It occurred before the last hydrant of the



first day of the flushing regimen was completed. The leak was not repaired until Wednesday, May 12 so the second day of hydrant flushing did not happen.

The District consumed 97,000 gallons of water on the first day of the leak and 88,000 on the second. Until then, our daily con-

sumption average for the month prior was approximately 10,000 gallons per day. Thank you to the nine residents of the nine houses and the Baptist Church for patience and understanding; their water supply was minimal during the 48 hour period.

The Cornell Internet of Things Team worked on our well water monitoring project at the pumphouse for 3.5 hours on Saturday May 15. We are fortunate to have a team of smart, enthusiastic, and dedicated people working to set this up. I was impressed to see how they doggedly approached issues of calibration and setup of the sonar system.

SUPERVISOR'S UPDATE

EHOLD, SUMMER IS AT HAND and, with it, the Bend of the pandemic is in view. Although not yet voted on at the time I write this, I expect the Town Board to vote at its May 19 meeting to reopen Danby's Town Hall to walk-in visitors. We are not yet ready to resume in-person meetings because the Governor has not yet lifted the physical distancing requirement. Until he does, Town Hall has a maximum capacity of 18 or so, which we could easily exceed if a hot topic came up. Since the CDC has now lifted both mask and distancing requirements for those fully vaccinated, we could resume normal meetings on a segregated basis, asking the unvaccinated to sit apart and distanced from each other. Awkward! Stay tuned. We are in the meantime setting ourselves up so you can still attend via Zoom even after in-person attendance again becomes an option.

Library Requests Town Hall Access

It was a request by the library volunteers to allow their patrons to access Danby's Town Hall to browse the available books that drove the discussion to open the building to the public. The request was approved during the Town Board meeting on May 19 and you can read the details in the Library article on page 6.

Solar Farm Proposed

While modest in scale compared to the hundreds of acres of solar farms being developed in Towns all around us, Danby has been approached by a solar developer (David Norbut) seeking to locate a 15 megawatt array on about 70 acres of land northwest of the houses on the lower part of Bald Hill Road. This came as something of a surprise to me since, like many others I was under the impression that Danby has not been explored for solar farm use (despite hundreds of acres of fallow, former farm fields now in brush) because of the absence of nearby high voltage transmission lines. Turns out that the capacity of the lines on NYS Rt.96B are adequate for a farm of this limited scale. The proposal would require the subdivision of the 70+ acres into three lots (because the sites are packaged in 5-megawatt increments) and there is not enough frontage on Bald Hill Road for that. The way to approval will thus involve creating a Planned Development Zone, rezoning the property to accommodate the proposed use. That is a discretionary Town Board action. There will be environmental review and opportunity for public comment before the Town Board acts. In fact, there will be two opportunities for public comment since the proposal (assuming it makes the move from concept to submitted application) will be referred to the Planning Board for its review and recommendation before the Town Board acts.

There are plusses and minuses to this, as with any change. This property is within the area proposed to be included in a hamlet growth zone. Putting a solar farm there would foreclose that option for quite a while, although not necessarily forever. The racks are mounted on helical piers that simply screw into the ground. They are easily unscrewed as well, restoring the site at end of

Home Energy Assistance

I'M ON A MISSION TO INFORM Danby residents about several energy-related topics. Today, I'm going to address a program available to you that you might not be aware of.

It's called HEAP—Home Energy Assistance Program. HEAP gives low-income households assistance with heating and cooling their homes. It is a lump sum that is sent directly to your electricity provider (NYSEG) and appears on your bill as a credit. The program begins in November of each year and runs until all program funds are expended. Google "HEAP NYS" to learn more about the program.

If you think you qualify, you can apply online or by contacting the Tompkins County Department of Social Services (607.274.5264). If you receive HEAP, you will not only see the HEAP credit on your bill, but you

will also see something called Energy Assistance Credit. Qualifying for HEAP and receiving the energy assistance credit can help you quality for at least some of the following Federal programs as well. Google each program to learn more about them and how to apply.

- Medicaid
- Food Stamps/EBT/SNAP
- SSI (Supplemental Security Income)
- Federal Public Housing Assistance (Section 8)
- TANF (Temporary Assistance for Needy Families
- NSLP (National School Lunch Program)
- Veteran's and Veteran's Spouse Pensions
- Lifeline (the phone/cellphone/broadband assistance program)

Qualifying for HEAP can help you qualify for some of the low-income homeowner programs offered by Tompkins Community Action and Ithaca Neighborhood Housing Services. Check out its web site to learn about the work they do.

life. A plus for the idea is the investment in renewable energy right where it could be used. The array would not be much seen from the main road or Bald Hill Road either, which some might see as an advantage. David already has approval for a similar, but slightly larger, array in Enfield. He buys the property rather than rents it, so he is invested in the communities where the arrays are located. His company is based out of Rochester. More on this to come, for sure.

ODA Approval Sets Stage for Subdivision Approval

Approval for an application to subdivide a 90-acre property southwest of the intersection of Marsh and Deputron Hollow Roads cleared a meaningful hurdle when the Town Board approved an Open Development Area for the parcel during its May 10 meeting. Although the name implies that an area is being opened up for development, that is not necessarily the case. What the ODA mechanism accomplishes is to enable a property owner to obtain a building permit for a house where the access is by easement (driveway) instead of directly fronting on a road. Access by easement is less disruptive than building a road just to create the frontage. If additional lots can then be created without a need for road frontage, though, allowing an ODA really could make it a lot easier to develop the property it is approved for. In this case, the potential is mitigated by the property owner's willingness to relinquish almost all of the development rights via a conservation easement with the Town. One lot (the westernmost) will have no retained development rights, the middle one already has two dwelling units on it and no more are allowed. The third, easternmost, lot has the retained right to build a single principal dwelling with the possible future addition of an accessory dwelling unit. The Town Board was willing to create the open development area with this conservation easement in place to protect from further development. The action now shifts to the Planning Board to approve the subdivision into the three lots. That was on the agenda for the May 18 PB meeting.

Planning Process Starts to get Concrete

Both the Conservation Working Group and the Hamlet Working Group are meeting twice a month to home in on how to rezone the Town and create the associated regulations. As I suggested might happen last month, the Town Board has added an extra meeting a month to review the progress and provide direction. In an effort to speed the process, the Planning Group is not acting as intermediary between working groups and Town Board. We hope to make the bulk of the major decisions before the year ends so the moratorium on subdivision in the low density zone doesn't have to be extended.

At this point, a roughed out zoning map is being reviewed by both working groups. As currently envisioned, the low density zone would be divided into at least four types of zones, ranging from suburban character to high priority preservation. That working map

COUNTY LEGISLATURE UPDATE

Establishing the County Budget is a big piece of what the County Legislature works on each year. Last month, we took the first step, which is to set a budget goal. The goal we set is for a 1.9 percent increase in the tax levy, and a small decrease in the tax rate. This would mean that if your assessment does not increase, your tax rate would actually go down slightly. On average though, countywide assessment are rising. The median assessment of a home is now \$200,000. That theoretical, median-priced home would see a \$24 increase in its County tax bill next year if we stay with the current budget numbers.

This budget is meant to be a maintenance-of-effort budget. We are seeking to continue doing what we are doing without adding many new initiatives. Changes to the budget and to the tax levy can be made in the Fall, and with all the ongoing uncertainty, significant changes are possible.

One interesting fact I learned that impacts our budget and taxes is that 41 percent (by dollar value) of Tompkins County is tax-exempt. That's a very high number for a county and it does require the taxpayers to support the tax-exempt entities, at least to some extent.

After every census, the County is required to redistrict. When we last did this 10 years ago, we established an independent redistricting commission. We were the only county in the state to do that. We will again have

an independent redistricting commission. We will be setting up this commission over the next few months, with September being when we expect the census data to be released.

Whatever redistricting plan is produced by the commission still has to be approved by the County Legislature. That is a New York State requirement, and it does make the process a little less "independent". However, ten years ago, the redistricting commission recommended reducing the size of the County Legislature from 15 members to 14. The County Legislature accepted that recommendation.

Due to the quirks of the calendar, the new districts will not take effect until 2025.

Because of math and geography, most of the towns in Tompkins County are split into different County Legislative districts. The Town of Ithaca is the most extreme example where five different legislators represent sections of the town. Danby, Caroline, Newfield, and Ulysses are the only towns in the county to have their entire town fall within one legislative district. I think it is best for a town to be in just one district, and I will be asking the redistricting commission to keep towns intact as much as possible.

will be posted on the Town's web site for your examination and feedback, once it gels a bit. It will probably be published in the Danby News for the same reason. Better to influence its shape and direction earlier than later, though, so your participation is most valuable at this formative stage. The working group meetings are easily accessed by going to the Town's web site calendar and clicking on the event. Ted also typically puts the meeting info on the Danby News calendar as well if you want or need to call in. In person attendance may also soon be an option.

Another working group has formed, led by Alyssa DeVilliers and Betsy Keokosky, focused on agriculture and how we can support it in Danby. That group will address

how zoning changes could help or hinder as an early priority since that is important to the rezoning process. The group has met once so far, in-person in Dotson Park. If you would like to join that group, which seeks to engage the whole range of people doing ag-like things, from backyard gardeners to large-scale (for Danby) farmers, contact Alyssa [adevilliers@townofdanbyny.org] or Betsy [bkeokosky@townofdanbyny.org]. Participating in Town Meetings A Brief Zoom Tutorial

Since Spring 2020, Town Government has been happening largely by videoconferencing using Zoom. Here's how to join a meeting *in the comfort of your own Home*.

- ① If you don't have internet, you can dial in with any touchtone phone. It's a lot better with video, though.
- ② If joining with video, download Zoom from [zoom.us]. It's free. Run the program; you don't need to establish an account, but it can be convenient to do so. Most default settings are acceptable. It is worthwhile to check for updates every month or so.
- ③ If the Zoom MeetingID and PassCode aren't in the *Danby News*, try going to the Town web site calendar. Click on the event. There's usually a link there that'll run Zoom and get you into the meeting. Phone callers, you'll also find the MeetingID and PassCode on that page, along with a phone number to dial.
- 4 Turn on your audio and/or video. It's polite to keep your audio muted until you have something to say (and to wait to be recognized). It's also useful to set your *screen name*, although you don't have to.
- ⑤ The Town Board has recently chosen to disable Zoom's chat function. Side conversations between members of the public are still possible using text messaging (display your phone number?) and other programs outside Zoom.
- 6 Similarly, Zoom recording is not permitted by default, and you must use a third-party program to record the meeting. Screenshots work, though.
- Most computers, these days, have a built-in mic. It works fine...but *any* dedicated microphone is bound to help you sound better, if that matters to you.
- ® Video participants, the control to raise your hand is located in the *Participants* panel (show it by clicking on the like-named control at the bottom). Phone callers, you can mute/unmute yourself by dialing "*6" and you can raise/lower your hand with "*9". Meeting chairs often miss raised hands so, and only as a last resort, speak up and ask to be recognized.
- ✓ In general, meetings have one or two opportunities for you to speak your mind. Almost all meetings have *Privilege of the Floor* at the beginning; three minutes

CAC UPDATE

SINCE I LAST WROTE, the Conservation Advisory Council has had a couple of meetings and has sponsored two virtual presentations by CAC members. Jonathan Zisk led a workshop, targeted at Danby residents interested in donating an easement on their property, on Danby's Conservation Easement Program. Our invasive species expert, Brittany Lagaly, gave a presentation on the Spotted Lanternfly, an insect from Asia that has recently been detected in our area and poses a severe threat to Finger Lakes vineyards and orchards. Brittany has also given a presentation to our Highway Department on how to deal with highly invasive and dangerous plants such as Japanese knotweed and giant hogweed. These presentations have been recorded and we plan to post them on the CAC page on the Town's web site.

Considerable progress is being made on drafting a Timber Harvesting Ordinance for Danby. It is currently being reviewed by the Town's Code Enforcement Officer, who would be tasked with enforcing the ordinance.

Members of the CAC have worked to finalize the terms of another conservation easement in the Deputron Hollow area. We are also considering some minor tweaks to the current conservation easement template and these will be discussed during our next meeting.


We briefly discussed a very preliminary proposal to site a 15MW commercial solar panel array in Danby, which had just been presented at a meeting of the Town Board. We also received reports from the three working groups of the Planning Group.

The CAC meets on the second Tuesday of the month. Our next meeting will be held (via Zoom) on June 8, 7pm.
