# SUPERVISOR'S UPDATE

#### December Approval For Rezoning?

The rezoning process is a bit behind the projected schedule, but there was enough wiggle room that it still looks like we can make the main changes before the year is out. If we can make that happen we won't have to extend the moratorium on subdivisions in the low density zone.

David West, our Town Planner, is in the final stage of incorporating suggested changes into a clean draft as I write this in mid-November. The Town Board is expected to schedule a public hearing on the result for either the first or second meeting in December. Check the calendar on the Town's web site for which it is to be. Unless serious changes are desired by the Board, the whole package will likely be voted on during the December 22 meeting.

To summarize the process, the charge was to bring the Zoning Ordinance into alignment with the vision in the Comprehensive Plan. That plan calls for focusing growth in the population centers and discouraging it in the outlying areas. Secondarily, it was hoped that we could break up the existing low density residential zone, which encompasses just about all of the Town outside the Danby and West Danby hamlets. Nearly two years later, what is proposed?

To facilitate growth in the population centers, restraints on density have been largely removed. There are design guidelines to encourage attractive housing that will be seen as enhancements to the existing housing. How much can be built on a lot will be determined by height limits (the existing 36 feet is maintained) and minimum setbacks from lot lines, but the main constraint will remain the need to comply with County Health Department requirements for water and wastewater. To develop at true hamlet density, we will need to enable shared systems, both on and off site. We have been granted money to study our options by the State and will do that in the next year. That work is needed to support the rezoning but is not part of it.

Outside the hamlet center areas and the neighborhoods that are proposed to surround them (check out the map on the web site), what is now the low density zone would be divided into four new zones. I should mention that in all zones, lots currently buildable would remain so. The new rules apply to newly-divided property.

The most protected zone includes the State Forest and already protected areas—just in case their status were to change in the future (for example, if the State were to sell off the forest).

That zone, called *High Priority Preservation*, would be developed at a 25-acre density (meaning an average of 1 lot per 25 acres--actual lots could be bigger or smaller as long as the average was met). Next is the *Rural Character-1* zone (R-1), which includes areas of steep slopes, wetlands, and large contiguous mostly undeveloped areas. Because of the sensitive nature of much of this land, site plan review would be required for most development there. In that zone, the average density is 10 acres, with clustering encouraged to maximize the retention of undeveloped open space. Clusters would have to be separated from existing housing by at least 600 feet. In an effort to protect more of R-1, we also propose to enable transfer of development rights out of--but not in to--of R-1.

The *R-2* zone is similar to the R-1 zone except that allowed uses are less subject to review. Same density as R-1, but development rights can be transferred out of R-1 and in to R-2, increasing the density somewhat as a result.

Development rights can also be transferred to the last of the outside-of-the-hamlets zone, the *Low Density Residential* zone. The rules of the existing low density residential zone would mostly still apply to these areas, hence the retained name. These parts of the Town are mostly built out under the current rules and are neighborhoods in their own right. A little more development would be enabled by transferring rights from the R-1 and R-2 zones into LDR.

The transfer of development rights feature of the zoning proposal is an effort to encourage giving up of development rights in R-1 and R-2. The sense of the Planning Group was that we should not propose a density reduction beyond one dwelling unit per ten acres. While densities lower than that (some jurisdictions have mandated 1 per 50) are legally allowable, the group didn't think they would be reasonable or fair. Transfer of development rights encourages a further reduction in developed

density, but the landowners would be paid for the rights they give up voluntarily. Extra credit would be given for rights ceded in areas where the Town would really not like to see development such as adjacent to seasonal roads.

There are new overlay zones proposed as well. We already have an overlay zone to protect high vulnerability areas of our aquifers. A new zone would create buffers adjoining streams outside the hamlets. Another would keep wildlife corridors unobstructed. The boundaries for this zone have yet to be determined. An overlay zone that would enable agriculture-supporting light industrial facilities would "land" on a property if a facility were proposed for it that satisfied the criteria for its creation. Those criteria include a 20-acre minimum lot size, large setbacks, and restrictions designed to minimize the potential for adverse impacts off-site.

The full text of the proposed rezoning and associated map can be found toward the bottom of the Planning and Zoning page of the web site.

#### **Budget Approved**

The approved budget includes more money for the Highway department, especially for equipment repair for our aging fleet and more for snow removal. While my proposal to extend proportional health care benefits to our part-time employees was not approved, the Board did respond to a very effective request from our Town Clerk and raised the pay for the Deputy Town Clerk. The Danby Community Council asked for and got support for having its Youth Programming person be made full-time. Danby is a challenging place to provide programming for our kids because we lack a school and its associated facilities. Offering only a part-time position to the provider compounded the problem of attracting and retaining good talent.

The West Danby Water District taxes (levied only on properties in the District) will be going down by more than 50 percent—not because expenses are down, but because in January the District will be raising rates for water usage rates. Revenues will cover more of the operating costs and taxes less. The water usage rates have not risen since the District became operational in 1969, so

The purpose of the CAC is to advise in the development, management, and protection of the Town's natural resources. The CAC administers the Danby Conservation Easement Program and actively seeks Danby landowners interested in preserving and protecting their land from future development.

We also arrange talks on a variety of conservation issues, including the current Agricultural Education Series (see separate article). Another ongoing project is to develop a Timber Harvesting Ordinance. This will not limit the size of timber harvests, but will alert the Town as to where logging is taking place and help ensure that damage to neighboring properties and roads doesn't occur.

The CAC meets on the second Tuesday of the month. Our next meeting will be held (via Zoom) on December 14, 7pm.

over time more and more of the revenues came from taxes on district property owners.

The tax levy passed by the Town has increased around 7 percent relative to 2021. That translates to around \$38 dollars more per \$100,000 of assessed value.

## COUNTY LEGISLATURE REPORT

ANY STATE LAW WAS INSTITUTED about 5 years ago requiring each county to convene an annual process to look at possible ways for municipalities to share services and save money. The current plan is looking at the possibility of all the Highway Departments across the county bulk-buying cutting edges for various pieces of equipment. Also, the Municipal Health Insurance Consortium will be expanding into surrounding counties to will lower the cost of health insurance to government insurance plans and, therefore, lower the cost to taxpayers. Future topics that will be studied as possible shared services include countywide information technology, purchasing, watershed management, electric charging stations, and animal control for municipalities.

Tompkins County will be conducting a study in 2022 to look into the possibility of countywide code enforcement. This is just a study—not a plan and not a commitment to implement countywide code enforcement. There is not one specific end-product in mind, but some possible benefits could include more health, safety, and fire inspections, better energy-efficiency implementation, more consistency between municipalities, and cost savings to the municipalities. A countywide code enforcement system would not automatically mean that the Town of Danby's local enforcement would disappear.

As I wrote about last month, the idea for a countywide broadband internet system seems to be dead for now. Instead, the approach being taken is to see what can be done to fill in the gaps where no coverage currently exists. A regional planning organization called Southern Tier 8 has applied for a grant to cover 78 additional homes in Danby, as well as homes in Caroline and Newfield. There was already a tremendous amount of grant money available for broadband expansion. With the passage of the federal infrastructure bill last month, even more money will now be flowing. There are no guarantees, but there is reason to be optimistic.

There has been much discussion at all governmental levels about the broadband coverage issue, but almost nothing about the cell phone coverage issue. I hope to change that. I have started discussions about mapping the existing coverage areas and developing a plan to fill in the gaps. But I have to admit to knowing very little about this topic. Also, I have not yet found any stories of municipalities stepping in to fill the gaps in cell phone coverage areas. ## Wrapping It Up


THE TOWN HAS JUST COMPLETED "wrapping up" its Highway Garage Clean Energy Community project and the building is now all snugged up against the elements.

You're welcome to see the results of this project! Visit the Highway Garage, 93 Hornbrook Road, during its open house on Saturday, December 4, 11am-2pm..

The Town of Danby was one of the first towns in the Southern Tier to earn a Clean Energy Community Designation from the New York State Energy Research and Development Authority (NYSERDA). It completed five high-impact clean energy actions including benchmarking, a community campaign, clean heating and cooling improvements, energy code training and a solar permit.

The Clean Energy Community funding helped enable the Highway Garage upgrades including air sealing hundreds of feet of leaky cracks in the interior wall surface, installing new insulated garage doors with remote control openers, and insulating the attic space to keep the cold out and the heating and cooling in.

Air source heat pumps were installed in the office areas and maintenance garage. They replaced the





grammable thermostats were added or updated. A new, smaller sized, electric hot water heater was installed, converting this to a renewable fuel source from current propane.

Improvements to the wastewater system were also made, reducing the amount of truck wash water that must be pumped and trucked out, reducing carbon transportation emissions.

The Town's Energy Committee plans to track and evaluate the town garage's energy usage and wastewater to analyze savings and environmental impact. The project will be documented and showcased, as an example for other communities.

# Maintaining Smoke Detectors and Fire Extinguishers

WITH DAYLIGHT SAVINGS TIME ENDED and winter on its way, it is the perfect time to recommit to regularly inspecting the fire safety equipment in your home. Smoke and Carbon Monoxide detectors and fire extinguishers that don't work are worse than useless in an emergency; they can lead to a false sense of security and endanger your and your family.

It's important to take a moment, ideally each month, to inspect your detectors and fire extinguishers. These days, you can purchase smoke detectors and CO-detectors singly or in combination and many come with 10-year batteries. While that's a good thing, even ten-year batteries wear out eventually or can malfunction, so regular testing is no less imperative.

Danby Fire Chief John Gaden and Wayne Westmiller, a Fire Protection Technician and certified NFPA 10 Fire Extinguisher Specialist, recommend monthly testing of detectors and a visual inspection of Fire Extinguishers. Below is guidance to make sure that the essential fire safety equipment in your home is in good working order.

- ① Smoke and CO detectors have a test button. Simply push and hold it to test. It will beep for a minute or so. If the detector does not respond then batteries need to be replaced or the detector replaced.
- ② Fire Extinguishers are inspected by looking at the pressure gauge and making sure the needle is in the green area and the pin is in the handle. The seal holding the pin in place should not be broken. Once a year, the extinguisher should be placed upside down for a minute or two to let powder loosen up inside it. Also, visually inspect the fire extinguisher to ensure there are no dents or rust on the body of the extinguisher. If anything is not in good working order with the extinguisher, you will need to have it serviced or replaced.

# **Danby Community Council** Youth Programs


