RESOLUTION 1.1

BE IT RESOLVED that the regular meetings of the Danby Fire District will be held at 7:30 pm on the second and third Tuesdays of even number months at the West Danby Fire Station, located at 47 Sylvan Lane, and of odd number months at the Danby Fire Station, 1780 Danby Road, Town of Danby, New York 14850, The location and time of the meeting may be changed by further resolution of the Board of Fire Commissioners upon proper notification to the local media of such change.

 - Compensation for services of officers or employees regularly engaged by the fire district at agreed wages by the hour, day, week, month or year.

Commissioners a copy of the annual report required by General Municipal Law Section 30, in lieu of a written statement showing his receipts and disbursements for the preceding fiscal year. This authorization shall remain in effect until rescinded by this Board of Fire Commissioners.
