Commissioner Westmiller moved to approve the November 17, 2015 minutes as presented. Motion seconded by Commissioner Freedman and carried with all in favor.

Commissioner Kokkelenberg moved to pay the vouchers as audited and approved on Operating Account Abstract 12 claims 262-283 in the amount of \$4816.59, and to authorize the Treasurer to pay all bills where invoices have been received and are due and payable on or before December 31, 2015.
