PURCHASING:

- Chief Wendt purchased a turbo draft jet syphon.
- Chief Gaden reported turnout gear will be ordered soon and he ordered flashlights

BUILDINGS/GROUNDS:

- Chief Wendt reported it appears the cheapest way to have internet at the West Danby Station is to go a contract with a cellular company i.e. AT&T or Verizon. Commissioner Faehndrich will research the 2 companies and also inquire about aircards for the new laptops the County is installing in certain trucks for every department in the county.
- Chief Gaden reported nightlights in new truck back will need to be replaced by electrician as they are 15 feet in the air, he will call D. Westbrook.
- Chief Gaden reported Zoning Officer Hansen contacted him about solar energy, he referred him to the Commissioners. Discussion held.

GRANTS:

- Commissioner Anderson reported she will check on the \$2,500.00 grant from Cornell and if it will rollover into new fiscal year.
- Commissioner Anderson gave an update on the sign purchase, she has contact Senator Seward's office in regards to a possible grant.
- Commissioner Kokkelenberg reminded everyone the AFG grant will be opening soon. Chiefs will work on a list of needed items and will prioritize the need for each item.

- Chief Wendt reported they are still working on specs for a brush truck and will have at July's meeting. We do have a grant out hoping to aide in the cost.
- Commissioner Westmiller discussed the Tahoe for sale by the Lansing Fire District. Commissioner Westmiller asked for permission to submit an offer to purchase for the Danby Fire District to replace West Danby's heavy rescue. The District would sell the current 1442. Attorney Butler will be asked to publish the permissive referendum.

Commissioner Westmiller moved to adopt Resolution 2016-06-21.1 to expend from the "Capital Reserve Fund for New Equipment" an amount not to exceed \$32,000.00 for the purchase of a EMS vehicle, cost of having present name/decal(s) if any removed and Danby Fire District name/decal(s) if any added on vehicle and any additional equipment or maintenance required; Motion was seconded by Commissioner Freedman. A roll call vote was taken and motion carried with 4 ayes and 1 absent.

Commissioner Westmiller made a motion to rescind Resolution 2016-02-09.1 in regards to bidding on 2009 EMS vehicle Cornell University is placing for auction. Seconded by Commissioner Freedman. A roll call vote was taken and motion carried with 4 ayes and 1 absent.

RESOLUTION TO EXPEND FROM CAPITAL RESERVE FUND FOR VEHICLE ACQUISITION

WHEREAS, pursuant to General Municipal Law §6-g, the Danby Fire District, Town of Danby, County of Tompkins, State of New York, did establish the "TTC 442 Res Equip New 17-4442", a capital reserve fund to finance the cost of acquisition of replacement fire fighting vehicles or the acquisition of additional fire fighting vehicles needed to be added to the existing fleet of fire fighting vehicles of the Danby Fire District, including, but not limited to, ladder trucks, pumpers, tankers, rescue vehicles, squads and vans; and

WHEREAS, the Danby Fire District wants to make a bid for the purchase of an EMS vehicle equipped with EMS cabinets and miscellaneous firefighting lighting; and

NOW THEREFORE BE IT RESOLVED THAT the Danby Fire District is hereby authorized to expend from the "TTC 442 Res Equip New 17-4442" an amount not to exceed \$32,000.00 for the purchase of an EMS vehicle, cost of having present name/decal(s) if any removed and Danby Fire District name/decal(s) if any added on vehicle and any additional equipment or maintenance required; and

IT IS FURTHER RESOLVED that this resolution is subject to permissive referendum pursuant to General Municipal Law 6-g."
